# 07/1120/16 ACCESS TO UNNAMED ROAD AT REAR OF PANDANUS CARAVAN PARK, DAVIDSON STREET, PORT DOUGLAS

"That the Committee does not approve the applicant's request to gain access to the unnamed road at the rear of Pandanus Caravan Park, Davidson Street, Port Douglas, on land described as Lots 1 & 2 on RP723702, Parish of Salisbury, and located at 97-107 Davidson Street, Port Douglas, for the following reasons:

- 1. the subject site is already serviced by an existing access off Davidson Street;
- 2. existing screening provided by natural vegetation will need to be removed to provide access to the subject property;
- 3. potential for odour issues following removal of existing vegetative buffer;
- 4. potential for visual amenity issues following the removal of existing vegetative buffer; and
- 5. the unnamed road at rear of subject site is currently used by chemical delivery trucks, contractors and Council staff associated with the operation of the Port Douglas sewage treatment plant. Formalisation of this road will result in increased interaction between sewage treatment plant operations and the general public."
