Recently when we completed our refresher course we were reminded that if someone suffered a serious heart attack they would not survive, as by the time assistance arrived from Mossman it would be too late.

The course instructor encouraged us to look into purchasing a defibrillator for the township. Several local people would be trained to use it and perhaps if the need arose save lives.

We have a large number of tourists visiting our area and sadly have already had a death in one of the accommodation houses which perhaps could have been prevented if we had access to a defibrillator.

As you will see by the quote which I have enclosed is \$2995.00. This unfortunately is out of our reach, therefore I am writing to request your assistance in the purchase of this vital piece of equipment.

Hoping you can see fit to help us in this very urgent request.

I am writing to you on behalf of the Miallo State School P&C to request funding to support the upgrade of our cricket pitches and practise nets.

Miallo State School and its surrounds is a growing community and we feel our school has a lot to offer our surrounding areas including Whyanbeel, Bamboo, Somerset, Syndicate and Newell. With our Principal on site in the Principal's residence, we have an open gate policy after hours and make our tennis courts and playgrounds available to anybody in the community who wishes to use them, providing they are treated with care and respect.

We are currently fundraising to resurface our cricket pitches and practise nets for a sport that is very popular with many of our community members, many of whom are members of the Douglas Cricket Association. At present the closest practise nets are at the Mossman and Port Douglas Primary Schools.

We have applied for several quotes for the upgrade and costs look at being around \$6000. We rely heavily on our community for fundraising and are hoping to raise these costs with the revival of our school fete this year but we would greatly appreciate any donation the council can make to help offset these costs.

DAINTREE BUY-BACK TRANSFER OF LAND

FROM

At it meeting in October, Council resolved to:

- ⇒ offer to sell three properties to EPA,
- ⇒ transfer 32 properties at no cost to EPA
 - request that EPA support Council in seeking a refund of duties pay from Office of State Revenue
- and to engage WGC to advise on appeal options regarding duty paid and to advise if there was an option to seek a refund from EPA through the Deed of Agreement.

The specific resolutions, and action taken is below.

1. offers to sell the three (3) properties it purchased in March 2004 to the State of Queensland (represented by the Environmental Protection Agency) for \$134,874.90."

Action: WGC recommended that Council change this resolution to make the contracts of sale conditional upon EPA refunding all duty paid, including the additional assessment and penalties.

2."That Council offers to transfer the title of the thirty two (32) properties purchased between October 2004 and June 2005 to the State of Queensland (represented by the Environmental Protection Agency) at no cost as per the Daintree Land Acquisition Agreement."

Action: WGC has been instructed to prepare paperwork.

3."pays to the Office of State Revenue, the additional assessment and penalties by no later than 26 October 2007, or the date of filing Council's appeal (whichever is the earlier date);

Action: Council needs to pay Office of State Revenue.

EPA advised it would not pay the additional assessment and penalties amount, but confirmed it would support Council in a submission to have the duty refunded. Based



upon this, WGC recommended to make the contracts of sale conditional upon EPA refunding all duty paid, including the additional assessment and penalties. (See 1.)

4. & 5.

Action: Covered above (See 1.)

6. in conjunction with the above offers, request the EPA to support Council in a submission to have the transfer duty paid by Council (including the initial transfer duty paid) reimbursed and to support Council in its appeal again the initial assessment.

Action: EPA has agreed to support Council in its appeal against duty paid upon transfer of the land to EPA. However, if Council adopts the action recommended under 1, this resolution would become redundant.
