- All rates that have been deferred between 2003 and 2007 totalling about \$33 900 be paid out in full from the budget allocation of \$40 000 for the financial year 2006/07.
- Those properties that have been assessed under the policy then receive the relevant rate rebate for the property (on average 60%) for the financial year 2007/08 and onwards until the policy is terminated by Council.
- Those properties that have been receiving rate deferral but do not have Nature Refuge Agreement on them be contacted to ascertain their willingness to enter into a Voluntary Conservation Agreement with Douglas Shire Council as a Statutory Covenant under the Land Title Act. If they are unwilling to enter into such an agreement then Council has the option of accepting that the rates are deferred from 2003 2007 but then charging rates again for the financial year 2007/08 and onwards. If the landholder agrees then the rated as assessed under the policy from 2007/08 onwards.
- Those properties that have Nature Refuges Agreements that are perpetual covenants but have not had rates deferred are to be assessed as being eligible for a rate rebate for the financial year 2007/08 according to the policy and to receive a rate incentive from that date onwards. No legal or surveying cost is concurred to the Council in this instance.
- Those properties who are noted on the Rates Incentive Program file but who do not have a covenant in place and have not had rates deferred are to be contacted as soon as possible to ascertain whether the landholder is still interested in the Rates Incentive Program and whether or not the landholder would be interested in entering into a covenant with the Council. These properties are then assessed for a rate rebate in the financial year 2007/08.
- Council to commit a proportion of the budget income (recommend between 0.25% 0.5%) each year to go towards delivering rates incentives in the Shire. If there is excess available budget then an Expression of Interest is advertised to attract other eligible landholders to the program.
- Council revise the policy for assessing properties under the Rates Incentives Program."
