#### 06/1017/35 SWIMMING POOL INSPECTION PROGRAM

Moved Cr Berwick

Seconded Cr Sciacca

"That Council delegate authority to the Chief Executive Officer to initiate legal proceedings in the Magistrates Court in circumstances where pool owners fail to comply with building code requirements for swimming pool fencing subsequent to reasonable notice for compliance being issued in accordance with the following:

- *initial inspection by pool compliance officer;*
- enforcement notice issued, twenty (20) business days to reasonably comply with the notice and to consider owners' representations;
- reinspection of matters raised in the enforcement notice, generally within fourteen (14) days of the notice expiring;
- consideration of application of on-the-spot penalty for non-compliance (\$525);
- follow-up letter detailing outstanding areas of non-compliance extending compliance period by fourteen (14) days;
- reinspection within approximately twenty-one (21) days;
- if still non-compliant, a "Complaint General Purposes Made, and Summons" and on-the-spot penalty be issued."
