RECOMMENDATION

That Council adopts the Rates Rebate for Permits to Occupy Land on Daintree River Policy.

EXECUTIVE SUMMARY

Pursuant to Section 120-122, *Local Government Regulation 2012*, Council may grant concessions to ratepayers who satisfy eligibility criteria.

Council offers a rates rebate for Daintree River huts as outlined in Council's Revenue Statement. The Rates Rebate for Permits to Occupy Land on Daintree River Policy establishes the guidelines and level of assistance Council will grant to eligible ratepayers. The Policy was adopted on 23 February 2021 and is due for review. There have been minor administrative changes to the policy such as date changes and updating the name of the relevant government department.

PROPOSAL

That Council adopts the Rates Rebate for Permits to Occupy Land on Daintree River Policy.

78. RATES REBATE FOR PERMITS TO OCCUPY LAND ON DAINTREE RIVER POLICY

Intent

The purpose of this policy is to establish the process for the provision of a rates rebate on rateable land on the banks of the South Arm and the Heads of the Daintree River that are occupied by holders of Permits to Occupy (fishing huts) which have been issued by the Department of Natural Resources and Mines, Manufacturing and Regional and Rural Development under the *Land Act 1994*.

Scope

This policy only applies to holders of Permits to Occupy (fishing huts) for land located the banks of the South Arm and the Heads of the Daintree River.

Provisions

Under the provision of the *Local Government Regulation 2012*, Council may resolve to grant a ratepayer a concession for rates and charges provided the specified criteria is met by the ratepayer. To be eligible for this rebate, the following conditions must be met:

- i. The property is located on the banks of the South Arm or the Heads of the Daintree River.
- ii. A permit to occupy for "fishing hut" has been granted by the Department of Natural Resources and Mines, Manufacturing and Regional and Rural Development.

Council will provide a rates rebate of 50% of the general rate only. This rates incentive will be credited to the recipient's rates notice prior to being issued.

Any benefit provided to a landholder through the Rates rebate program must be repaid to Council from the date of revocation or cancellation of the permit to occupy, if the Permit to Occupy (fishing hut) has been revoked or cancelled by the Department of Natural Resources and Mines, Manufacturing and Regional and Rural Development.
