RECOMMENDATION

That Council:

- 1. In accordance with s235(c) *Local Government Regulation 2012*, retrospectively endorse \$18,551,916.14 in Reconstruction of Essential Public Assets expenditure committed in June 2025, in relation to the Cyclone Jasper Disaster Event.
- 2. Council to note the funding received to date from Queensland Reconstruction Authority (QRA) for Reconstruction of Essential Public Assets.

EXECUTIVE SUMMARY

Cyclone Jasper impacted the Douglas Shire Council region on 13 December 2023, followed by a significant rain event (the Cyclone Jasper Disaster Event). The disaster event has resulted in a large amount of damage to the Douglas Shire assets and resultant expenditure for repairs, which is outside the approved budget.

This report seeks to obtain retrospective endorsement of expenditure committed by Council for the period 1-30 June 2025 for Reconstruction of Essential Public Assets.

BACKGROUND

Per Item 6.8 of the Ordinary Council Meeting held on 30 April 2024:

That Council:

- 1. Delegates authority to the Chief Executive Officer (CEO) to award contracts valued at more than \$200,000 associated with Tropical Cyclone Jasper recovery works.
- 2. Delegates authority under s257 of the *Local Government Act 2009* to the Chief Executive Officer to negotiate, finalise and execute any and all matters related to the awarding of those contracts.
- 3. Notes that, in accordance with Council's Procurement Policy, Council will retrospectively consider all contracts valued at more than \$200,000 awarded by the Chief Executive Officer (CEO) associated with funded projects related to Tropical Cyclone Jasper.

Financial commitments for each month are being presented to Council for retrospective endorsement in accordance with Council's Procurement Policy and s235c of the *Local Government Regulation 2012*, in accordance with the resolution dated 30 April 2024.

COMMENTS

Following is a summary of the expenditure committed via contract awards for the period 1-30 June 2025, due to the disaster event:

Each contract is awarded by the CEO following a comprehensive evaluation process and review by the Chief Engineer. The evaluation process consists of assessment by an experienced panel with oversight from a probity advisor. The evaluation team conducts a detailed review of pricing, non-price criteria, and any contract departures, resulting in a weighted scoring that ranks the tenders for value for money. An evaluation report is prepared, reviewed and endorsed by the Chief Engineer for approval by the CEO. This process ensures robust assessment and governance for all packages of work.

Each successful supplier has been through this process, with the delivery team confident that the successful tenderers offer the best overall value—balancing risk mitigation, scheduling efficiency, and minimizing community impacts.

- 1. In accordance with s235(c) *Local Government Regulation 2012*, retrospectively endorse \$18,551,916.14 in Reconstruction of Essential Public Assets expenditure committed in June 2025, in relation to the Cyclone Jasper Disaster Event.

FINANCIAL/RESOURCE IMPLICATIONS

The Cyclone Jasper disaster event occurred and has resulted in a large amount of damage to Douglas Shire assets and resultant expenditure for counter-disaster operations and emergency repairs and remediation.

In accordance with s204 of the Local Government Regulation 2012, monthly financial reports which record the progress against the budget will be presented to Council. These reports will include expenditure committed as a result of the Cyclone Jasper Disaster Event for Reconstruction of Essential Public Assets and any funding received by Council.

There is a significant risk if funding is not approved that this would slow down or halt the recovery process after ex-TC Jasper.
