## **EXECUTIVE SUMMARY**

An administrative error has been identified regarding the reference of the *Local Government Regulation 2012* when Council has resolved to move into a closed session. The report seeks to rectify the incorrect reference.

## **BACKGROUND**

The closed session reports tabled at the Ordinary Council Meetings date 17 June 2025 and 12 August 2025 incorrectly referenced the *Local Government Regulations 2012* section 275 as the legislation that enables Council to resolve to move into a closed session. The correct reference is *Local Government Regulations 2012* section 254J.

## **COMMENTS**

Council officers contacted the Local Government Association of Queensland (LGAQ) regarding this administrative error and sought advice as to the process to address the administrative error and the legality of the resolutions associated with the items discussed in the closed session.

It was advised that a new motion correcting the record is the correct way in which the matter be addressed. The motion should be a standalone report (this report). The error cannot be rectified through the process of confirming the meeting minutes, as it was an administrative error in preparing the motion rather than recording it.

Regarding the legality of the resolutions passed following the aforementioned closed sessions, as the resolutions were moved correctly within the open session of the meeting, they will stand.
