7.6. DEADLY ACTIVE SPORT AND RECREATION FUNDING

RECOMMENDATION

That Council endorse for funding provided by the Department of Sport, Racing and Olympic and Paralympic Games, under the Deadly Active Sport and Recreation Program, be awarded to Bamanga Bubu Ngadimunku Inc.

EXECUTIVE SUMMARY

The Department of Sport, Racing and Olympic and Paralympic Games has written to Council regarding funding under the Deadly Active Sport and Recreation Program. Douglas Shire, as a community, has been awarded \$56,607.65 to support the delivery of community-identified physical activity opportunities for Aboriginal and Torres Strait Islander peoples. The Department is seeking a decision from Council on where the funding should be awarded.

This report recommends that the funding be awarded to Bamanga Bubu Ngadimunku Inc. (BBN).

BACKGROUND

The Deadly Active Sport and Recreation Program commenced in 2022 and was targeted at 17 identified discrete communities across Queensland, including Mossman Gorge. A total of \$188,336 has previously been awarded to BBN to deliver programs in the community. These activities include after school and holiday programs, and sporting activities such as boxing classes.

BBN is a not-for-profit incorporated association that represents the cultural, social and economic aspirations of the Mossman Gorge community.

COMMENTS

The Department have provided Council with three options:

- 1. Agree for the funding to be awarded to BBN in line with the funding arrangements previously agreed to for Years One to Three; or
- 2. Request for the funding to be allocated directly to Douglas Shire Council for delivery from 1 July 2025 to 30 June 2026; or
- 3. Request for the funding to be allocated to an alternative organisation.

As the funding is provided specifically for the Mossman Gorge community, it has been considered that BBN are the most appropriate organisation to deliver activities funded by the Deadly Active grant.

PROPOSAL

That Council endorse for funding provided by the Department of Sport, Racing and Olympic and Paralympic Games, under the Deadly Active Sport and Recreation Program, be awarded to Bamanga Bubu Ngadimunku Inc.

FINANCIAL/RESOURCE IMPLICATIONS

Should Council determine to receive the funding directly, additional resources would need to be found to facilitate the program. Additionally, Council would be responsible for the financial management and acquittal of the grant.

RISK MANAGEMENT IMPLICATIONS

If the funding is awarded to BBN, Council will absolve itself of any risk implications associated with the funding or activities.

SUSTAINABILITY IMPLICATIONS
