# 7.8. APPLICATION FOR TEMPORARY ROAD CLOSURE AND ROAD LICENCE - UNFORMED ROAD NEWELL

#### **RECOMMENDATION**

#### **That Council:**

- 1. Support an application by the landowner of 163 Newell Road, Newell, formally described as Lot 25 SP212664, for a temporary road closure and subsequent road licence over a section of unformed road, depicted within the application as the 'proposed temporary road closure and road licence area'.
- 2. Advise the Department of Natural Resources and Mines, Manufacturing, and Regional and Rural Development that Council, as the road manager, supports the application for a temporary road closure and subsequent road licence, by completing a Part C Form LA30: Statement in relation to an application under the Land Act 1994 over State land.

#### **EXECUTIVE SUMMARY**

Council has received a request to support an application by the landowner for a temporary road closure and subsequent road licence over a section of unformed road (the identified area shown in attachment 1.) adjacent to 163 Newell Road, Newell.

In accordance with the *Land Act 1994*, Council is the road manager for dedicated roads in its local government area. A Part C Form LA30: Statement in relation to an application under the *Land Act 1994* over State land, for lodgement with Department of Natural Resources and Mines, Manufacturing, and Regional and Rural Development (the Department), is the sole opportunity for the road manager to either support or not support the application.

# **BACKGROUND**

The identified area was previously subject to a road licence held by the owner of land immediately to the north, prior to reconfiguration of this land from one into two lots, now described as Lot 1 and Lot 2 on SP346868. The reconfiguration process required the previous licensee to surrender the road licence.

# **COMMENTS**

- A road licence is sought by the applicant to enable formalised use of the identified area. Should the Department ultimately grant a road licence, the intended use will be for the expansion of rural activities undertaken on the adjoining Lot 25 SP212664, specifically low-intensity cattle grazing, consistent with the current use of the land.
- An adjoining owner that shares a common boundary with a road can apply for a road licence.
- A road licence can only be issued over roads that have been temporarily closed.

- A road licence provides the licensee exclusive occupation rights of the temporarily closed road area, within the conditions of the licence.
- The identified area does not facilitate legal access to any surrounding properties, nor does it contain public utility infrastructure.
- No objections or concerns were received from the internal consultation process relevant to the proposed temporary road closure.

#### **PROPOSAL**

#### That Council:

- 1. Support an application by the landowner of 163 Newell Road, Newell, formally described as Lot 25 SP212664, for a temporary road closure and subsequent road licence over a section of unformed road, depicted within the application as the 'proposed temporary road closure and road licence area'.
- 2. Advise the Department of Natural Resources and Mines, Manufacturing, and Regional and Rural Development that Council, as the road manager, supports the application for a temporary road closure and subsequent road licence, by completing a Part C Form LA30: Statement in relation to an application under the *Land Act 1994* over State land.

#### FINANCIAL/RESOURCE IMPLICATIONS

All costs associated with an application for a temporary road closure and road licence are borne by the applicant. Should the Department ultimately grant a road licence over the temporarily closed road area, the licensee will pay an annual licence fee to the Department.

#### **RISK MANAGEMENT IMPLICATIONS**

The road is temporarily closed from the day the road licence is issued. If the road licence is surrendered (by the licensee) or cancelled (by the Minister), the road is reopened. If in future Council requires the road to be reopened, Council can make a request to the Department to cancel the road licence. No compensation is payable to the licensee for the cancellation of a road licence.


