RECOMMENDATION

That Council resolves to:

- 1. Award Contract 2023-5386-5840-6098 Alexandra Range Safety Upgrade to Geo Construct Pty Ltd (ABN 42 640 635 445) for \$963,920.99 (GST exclusive).
- 2. Delegates authority under s 257(1) b of the *Local Government Act 2009* to the Chief Executive Officer to negotiate, finalise and execute any and all matters associated with the contract.

EXECUTIVE SUMMARY

Douglas Shire Council (Council) requires professional construction services to undertake pavement upgrades and slope stabilisation on Alexandra Range. Sections of the Alexandra Range feature steep embankments that undermine in heavy wet weather events and poses continual maintenance and disaster related issues. To address these concerns, Council requires earthworks, crossroad stormwater drainage and stabilisation improvements on two sections of Alexandra Range.

Table 1 displays the submissions received from an open tender invitation via Vendor Panel. The evaluation and recommendations were workshopped with the Councillors on 21 November 2023. A section of asphalt surfacing scope was tendered as an option and has not been included in the proposed award as all offers exceeded the available budget. However, since the project will not commence immediately, Council will review budgets of other infrastructure projects with the view of rearranging available funds so a variation can be issued for the excluded asphalt scope (possibly to be awarded once authorized in January 2024 Ordinary Council Meeting.

Officers recommend that the project be awarded to Geo Construct Pty Ltd for \$963,920.99 excluding GST. Failure to adopt this recommendation will result in works being delayed until next financial year and the unstable bank on Cape Tribulation Road could further deteriorate creating extended periods under traffic control, vehicle size limits and possible long term road closures.

The project will be delivered within the available budget.

BACKGROUND

The Cape Tribulation Road is a critical transport link providing access to the Daintree Rainforest World Heritage area north of the Daintree River.

This road is the only route north from the Daintree River Ferry to Cooktown via the Bloomfield Track. Reliable road infrastructure supports commercial entities and access for communities

north of the Daintree River. Tourism market research suggests Cape Tribulation and the Daintree Rainforest play a significant role in why people travel to the Douglas Shire.

Cape Tribulation Road crosses Alexandra Range, this steep and windy section of the road is surrounded by rainforest with very steep side slopes. Council staff completed designs to improve safety at two sections on the Alexandra Range. Works include bank stabilisation at one site and widening of a narrow section on Fern Gully.

COMMENTS

Council issued an open tender invitation through Vendor Panel for 2023-5386-5840-6098 Alexandra Range Slope Stabilisation and Fern Tree Gully Widening. The Vendor Panel reference number is VP383146. Table 1 displays the submissions received. Note, the pricing in Table 1 includes the cost for optional asphalt surfacing, which has been removed for budget compliance.

An initial compliance check was conducted on the received submission to determine the compliance with the contractual requirements and provision of requested information.

During the evaluation process, the submission was assessed against the evaluation criteria detailed in the request for tender (RFT) documentation.

Specific criteria were weighted according to their importance in delivering the project successfully and providing the best overall value for money solution in accordance with Council's procurement policies. The weighting attributed to each criterion is outlined in Table 2.

Geo Construct Pty Ltd was the highest ranked tenderer. They have extensive experience in the completion of slope stabilisation works like those required in the current tender including

design, construct and certify services on a number of slope stabilisation and civil construction works for DSC.

Their submission was detailed, had the most competitive price, and indicated they can complete the works within the desired timeframe. The tender evaluation panel recommends Geo Construct Pty Ltd as the preferred supplier. **Note:** A section of asphalt surfacing scope was tendered as an option and included in the tendered price of \$1,564,420.99. However, to remain within budget, the optional asphalt scope was excluded from the proposed contract award, bringing the revised contract total to \$963,920.99. Since the project will not commence immediately, Council Officers will review budgets and progress of other infrastructure projects to determine if funds can be reallocated to this project and a variation can be issued for the excluded asphalt scope. (If funds are available this will be presented to the January 2024 Ordinary Council Meeting for approval).

PROPOSAL

That Council resolves to:

- 1. Award Contract 2023-5386-5840-6098 Alexandra Range Safety Upgrade to Geo Construct Pty Ltd (ABN 42 640 635 445) for \$963,920.99 (GST exclusive).
- 2. Delegates authority under s 257(1) b of the *Local Government Act 2009* to the Chief Executive Officer to negotiate, finalise and execute any and all matters associated with the contract.

FINANCIAL/RESOURCE IMPLICATIONS

Council received funding through the Transport Infrastructure Development Scheme (TIDS) funding scheme and also committed funding in the capital works budget for the Alexandra range safety upgrade works.

This tender combines several projects into one larger project. The available budget of Council and the TIDS funding scheme totals \$1,239,028.00.

However, all tender submissions received exceeded the available budget. To remain within budget the optional asphalt scope was excluded, bringing the revised contract total to \$963,920.99.

The asphalt works intended for this project, currently excluded, may be completed under a variation.

RISK MANAGEMENT IMPLICATIONS

Failure to adopt this recommendation will result in works being delayed until next financial year and the unstable bank on Cape Tribulation Road could further collapse creating extended periods under traffic control, vehicle size limits and possible long term road closures. Furthermore, the TIDS funding contribution is only available until the 30 June 2024.

SUSTAINABILITY IMPLICATIONS

Economic: Reliable road infrastructure supports commercial entities and the

communities located north of the Daintree River. Tourism market research suggests that Cape Tribulation and the Daintree play a significant role in the reason why people travel to the Douglas Shire.

Environmental: The contractor will be required to fulfill all environmental obligations

during construction of this project

Social: Reliable road infrastructure north of the Daintree Ferry will positively

impact the communities north of the Daintree River by providing an important transport link. It also provides important access to emergency

service vehicles.
