# 6.8. TOURISM PORT DOUGLAS DAINTREE – ONE YEAR EXTENSION OF RESOURCE AND PERFORMANCE

#### RECOMMENDATION

Council agrees to a 1-year extension of the current Resource and Performance Agreement with Tourism Port Douglas Daintree at the current year's funding commitment of \$500,000 (ex GST).

#### **EXECUTIVE SUMMARY**

Tourism Port Douglas Daintree (TPDD) is seeking a 1-year extension of their current Resource and Performance Agreement with Council to 2024-25 with current funding of \$500,000 (ex GST). With Council elections imminent, and a new CEO for Tourism Port Douglas Daintree to be appointed, the extension will provide continuity in TPDD's operations and afford time to all new parties to become familiar with the tourism organisation, its strategic direction and its relationship with Council.

#### **BACKGROUND**

Council has a current Resource and Performance Agreement with TPDD over a 3-year term which expires as of 30 June 2024. The Agreement commenced on 1 July 2021, with Council funding \$400,000 for the first year. Funding increased in annual increments of \$50,000 over the duration of the term. TPDD request that the extension of the contract is maintained at the current year's funding commitment of \$500,000.

## **COMMENTS**

As part of the Resource and Performance Agreement, TPDD provides regular updates to Council staff and Councillors. TPDD's work has been key in increasing visitation to the Douglas Shire after Covid, with 2022 seeing a record number of people visiting the region.

#### **PROPOSAL**

Council agrees to a one-year extension of the current Resource and Performance Agreement with Tourism Port Douglas Daintree at the current year's funding commitment of \$500,000 (ex GST).

## FINANCIAL/RESOURCE IMPLICATIONS

Council would fund TPDD through an extended Resources and Performance Agreement for:

• \$500,000 (ex GST) year 2024-2025

The funding allocation in the current agreement is as follows:

- \$400,000 (ex GST) year 2021-2022
- \$450,000 (ex GST) year 2022-2023
- \$500,000 (ex GST) year 2023-2024

#### **RISK MANAGEMENT IMPLICATIONS**

In accordance with the extended Resource and Performance Agreement, Council's funding contribution will be acquitted through the provision of TPDD's Annual Report, and through the provision of strategic plans and quarterly reporting.
