

# MINUTES OF THE SPECIAL COUNCIL MEETING OF THE DOUGLAS SHIRE COUNCIL HELD ON TUESDAY, 8 JUNE 2021 COMMENCING AT 10.00AM

Mayor Cr Kerr opened the Meeting by welcoming everyone to the Special Meeting of the Douglas Shire Council being held on Tuesday, 8 June 2021 at the Mossman Council Chambers.

Cr Kerr gave notice that, in accordance with Section 277E of the Local Government Regulation 2012, the Ordinary Meeting of Council will be restricted in numbers of public attendance because of health and safety reasons associated with the public health emergency involving COVID-19; and advised that this Ordinary Meeting of Council will be available to view via Live Stream on Council's Website and will be available for others to watch at a later time.

The reason for Cr Kerr's belief is that one of Cr Zammataro's siblings operates a similar operation that could be affected financially, and that the public could be confused by this type of operation; and Councillors need to decide whether Cr Zammataro has a declarable interest in Item 3.5 "Operational Plan 2021-2022 Initiative – Continue to investigate Opportunities in RV Strategy".

Cr Zammataro advised the meeting that the Officer's report specifically refers to Mossman and has no bearing on his sister's operation in Port Douglas and believes that he has no declarable interest in the matter.
