#### INTRODUCTION

# Turtle Rock Café & Safari Lodge

A request for Council's comment has been submitted by the Department of Justice and Attorney-General, Office of Liquor and Gaming Regulation, for the Turtle Rock Café & Safari Lodge, located at 3903R Cape Tribulation Road, Cape Tribulation and described as Lot 4 on RP733181. A copy of the request is attached as *Attachment 1*.

# Type of Licence – Commercial Other Subsidiary on Premises Licence

If the license is granted it would enable the holder to sell liquor to a resident or guest of a resident for consumption on the premises at any time and up to 9 litres for consumption off the premises to residents only. Liquor may also be sold to members of the general public attending a function or in an area primarily used for the provision of meals prepared and served to be eaten on the premises (however, liquor may be sold in this area to patrons who are non-diners i.e. only there to have a drink).

### **Planning Scheme Requirements**

The land is included within the Conservation Planning Area. There are no planning concerns with regard to the approved use on the site.

The most current planning approval is TP381- 1 December 1987 for Camping Ground, Cabins, Restaurant and Ancillary uses. The proposed license is considered to be consistent with the approved use of the land.

# **Discussion/Comments**

Comments in relation to the proposed Liquor Licence were received from Council's Community and Economic Development Officer and Council's Environmental Health Officer.

# **Council's Community & Economic Development Officer**

The request for comment was forwarded to the Community and Economic Development Officer to provide comments on behalf of the CEO Unit.

The Community and Economic Development Officer supports the application provided that Responsible Service of Alcohol and Responsible Promotion of Alcohol standards are met.

### **Environmental Health Officer**

Environmental Health and Regulatory Services has assessed this application and offers no objection or concerns with the proposal.

Turtle Rock Café has a current Food Business Licence and Jungle Lodge (Safari Lodge) is licensed as a separate business with current Swimming Pool and Accommodation Permits under Council's Local Laws.

- The facts, evidence or reasons upon which it is based.

Accordingly, any objection to this application should be supported by documentary evidence on the specific trading history of this venue and include incidents directly linked to the operation of the premises and the conduct of the licensee and their management.

In the interests of natural justice, any comment or objection you provide may be referred to the applicant.

The Commissioner's decision may be subject to review by the independent Queensland Civil and Administrative Tribunal. Substantiating any comments or objections as requested will ensure the Commissioner's decision is appropriately evidence-based and more capable of withstanding scrutiny in any subsequent review.
