5.9. DAINTREE RIVER FERRY CONCESSIONAL TRAVEL GENERAL POLICY & FEES AND CHARGES

RECOMMENDATION

That Council resolves to adopt:

- 1. the Daintree River Ferry fares for the 2018/19 financial year; and
- 2. the Daintree River Ferry Concessional Travel Policy

EXECUTIVE SUMMARY

As part of its standard annual budget process, Council reviews its fees and charges for the upcoming financial year. This report presents the Daintree River Ferry fare structure to be adopted for the 2018/19 financial year.

In adddition, Council has maintained concessional travel arrangements for eligible people on the Daintree River Ferry for a considerable number of years. These arrangements allow regular eligible commuters to travel on the ferry at minimal cost which provides a significant social benefit particularly to those people residing north of the Daintree River. Council's general policy for Daintree River Ferry Concessional Travel is also presented for re-adoption.

BACKGROUND

Fees and Charges

All fees and charges established by Council are a "user pay" system for services provided and recouping costs through this revenue stream enables Council to minimise the level of rates and charges levied on ratepayers to fund operational expenditure.

Concessional Travel

Concessional travel fares were first implemented in 1985 and a history of these arrangements is detailed below:

From the inception of concessional travel arrangements, the cost to individuals has reduced from \$1.00 per trip (if an individual completed 1 return trip per week day that would equate to \$520.00 per annum) to \$16.00 for unlimited trips for 2 years.

The ability for Council to provide these ever increasing concessions to eligible residents and ratepayers has been created through revenue obtained from other ferry fares which fund ferry services including whole of life costs for required infrastructure.

COMMENT

Fees and Charges

In determining the ferry fares for the 2018/19 financial year, Council has taken into consideration community feedback. The author of this report would like to comment on the following two key points raised in this feedback:

- "Raising the fares will only continue to serve as both a deterrent for potential tourists considering travel north of the river and as a source of further aggravation for those that endure long queues when crossing at peak periods"
- "With the unexpected five day ferry closure earlier this year, Daintree tour operators lost business and revenue. Not increasing fares for the coming year would be clear evidence Douglas Shire Council supports the sustainability of Daintree businesses."

There is no substantive evidence that the cost of a ferry fare is a deterrent to potential tourists and in actual fact statistics recorded for the last two completed financial years have shown record numbers of self drive tourists visiting the region north of the Daintree River. Attachments 3 and 4 to this report are graphs which depict this increased number of travellers and the following information is of particular note:

- Self Drive Tourists. Return fares 2015/16 83,736 and 2016/17 87,739. Rolling average last 14 years 76,894.
- Self Drive Tourists. One way Fares 2015/16 24,808 and 2016/17 24,955. Rolling average last 14 years 17,913.

The dry docking of the ferry that occurred for five days over February/March 2018 was a legislative requirement enforced upon the ferry contractors and Council with little forward notice. The circumstances surrounding this event have been well documented in the media. To support not only business operators but also residents during this period, Council implemented measures and additional services over and above the ferry contract to minimise the inconvenience to all.

Apart from actions taken by Council during the dry docking, over the years Council has implemented other initiatives or undertaken activities to support the business owners over the Daintree River which include:

- Introducing multi day tickets at discounted prices to entice visitors to travel more often to north of the Daintree River.
- Establishing what is now known as the Douglas Card to entice visitors from neighbouring local government areas to travel to north of the Daintree River during the historically low tourist season.
- Conjointly with the Douglas Card, Council and Port Douglas Daintree Tourism Association promoted participating businesses north of the Daintree River through incentives provided by these businesses.
- Taking on an advocacy role with other tiers of government to improve services and lifestyle for the communities north of the Daintree River.

Council fulfills a community obligation in enhancing the local economy, assisting the promotion of our local government area in destination marketing and the delivery of a diverse range of Council services to maintain the attractiveness of this region.

Therefore there is no substance in the assertion that Council does not support the sustainability of Daintree businesses and this has no bearing on whether or not the ferry fares are increased.

Also contained within the ferry fares presented to Council for adoption is a provision to extend the currency period for concession cards that are due to expire on 30 June 2018 to 30 April 2019. This will effectively provide an additional 10 months of concessional travel, at no cost to the cardholder. Apart from the benefit to the cardholder, the renewal period will be diverted away from the end of financial year, which is an extremely busy period, to a quieter month allowing for the provision of enhanced customer service.

In addition approval is also sought to allow eligible cardholders to purchase another book of visitor tickets during this 10 month period should their circumstances warrant it.

During the month of April 2019, the renewal of concession cards will be advertised and the cards issued at that time will be valid until 30 April 2021. This will allow for implementation of any changes required under the new ferry services contract which will come into effect 1 July 2021.

Concessional Travel

The Daintree River Ferry Concessional Travel Policy has been reviewed to ensure administrative accuracies and has remained with the same content and intent. The only exception is clause 8 where the threshold of \$1,000 has been removed in support of charity events. Delegation remains with the Chief Executive Officer to assist with all reasonable requests for charity events utilising the ferry service.

PROPOSAL

That Council resolves to adopt the Daintree River Ferry fares for 2018/19 financial year and the Daintree River Ferry Concessional Travel Policy.

FINANCIAL/RESOURCE IMPLICATIONS

There are no financial implications to implement these recommendations if adopted by Council.

RISK MANAGEMENT IMPLICATIONS

There are no risk management implications to implement these recommendations if adopted by Council.

DAINTREE RIVER FERRY CONCESSIONAL TRAVEL GENERAL POLICY

Intent

The Douglas Shire Council will provide concessional travel upon the Daintree River Ferry to all persons who fulfil the eligibility criteria detailed in this document subject to the terms and conditions for such concessional travel being abided.

Scope

Concessional travel is only available to persons complying with criteria as detailed in this policy.

Provisions

1. DOUGLAS SHIRE COUNCIL RATEPAYERS AND RESIDENTS

Concessional travel will be offered as: - A universally barcoded card which includes the user's photograph. Expiratory date of cards is advised in Council's Fees and Charges, as is the cost of the card.

Eligibility Criteria

- (a) Ratepayers of Douglas Shire Council, resident or owning property in the Douglas Shire area.
 Ratepayer is defined as a natural person who is recorded as the owner of property.
 - (b) Once an eligible ratepayer purchases a concessional card, their spouse or partner will also qualify to purchase a card. Documents to confirm status will need to be produced.
- 2. (a) Residents enrolled on the Electoral Roll for Douglas Shire Council but who are living or own a business within the Douglas Shire area.
 - (b) Once an eligible adult purchases a concessional card, their spouse or partner will also qualify to purchase a card. Documents to confirm status will need to be produced.
- 3. Residents of the *Douglas Shire Council* who are not ratepayer/s or on the electoral roll but are able to provide the following two forms of identification:-
 - In all cases a valid Queensland driver's licence with current local address (i.e. *living in the Douglas Shire area*) recorded thereon; and
 - A lease agreement on rented premises located in the Douglas Shire area; or
 - A landline telephone account in the name of the applicant; or
 - An electricity account in the name of the applicant.
- 4. (a) An individual who lives north of the Daintree River, but within the Douglas Shire area, is ineligible to enrol on the Electoral Roll for the Douglas Shire Council and operates or leases a business in the Douglas Shire area or works in the Douglas Shire area.
 - (b) Documentation to verify eligibility under 4(a) will be required.
 - (c) Once eligibility under 4(a) has been confirmed and that individual has purchased a concessional card, their spouse or partner will also qualify to purchase a card. Documents to confirm status will need to be produced.
- 5. (a) An individual who lives in the Douglas Shire area, who is ineligible to enrol on the Electoral Roll for the Douglas Shire Council and operates or leases a business or works north of the Daintree River.
 - (b) Documentation to verify eligibility under 4(a) will be required.



- (c) Once eligibility under 4(a) has been confirmed and that individual has purchased a concessional card, their spouse or partner will also qualify to purchase a card. Documents to confirm status will need to be produced.
- 6. (a) An individual who is ineligible to enrol on the Electoral Roll or is a non-resident of the Douglas Shire area but is employed by a business registered within the Douglas Shire area and is required to travel across the Daintree River in the course of their employment.
 - (b) Documentation from the employer to verify eligibility under 6(a) will be required.
 - (c) The concessional card is to be used for work purposes only and not for private trips north of the Daintree River.
- 7. (a) To bona fide health workers employed by recognised health service providers, being government agencies of from private enterprise, who travel across the Daintree Ferry in the course of their duties.
 - (b) Documentation from either Queensland Health or Blue Care will be required to confirm eligibility under 5 (a).
 - (c) The concessional card is to be used for work purposes only and not for private trips north of the Daintree River.
- 8. (a) Where a Company, Firm or Partnership is a ratepayer of the *Douglas Shire Council*, then such Company, firm or Partnership shall be regarded as one ratepayer for the issue of a concessional card and will nominate one person only to whom a card may be issued. The property owned by the company, firm or partnership must be located within the *Douglas Shire area*.
 - (b) Documentation on Company, Firm or Partnership letterhead will be required in nominating a person under 6 (a).
 - (c) Once eligibility requirements under 6 (a) and (b) have been satisfied and that individual has purchased a concessional card, their spouse or partner will also qualify to purchase a card. Documents to confirm status will need to be produced.
- 9. Under special circumstances and depending on the reasons *given in writing to Douglas Shire Council*, to others that may be defined at Council's discretion.

Visitor Tickets

Also available to the eligible ratepayer owning property north of the Daintree River or an eligible resident living north of the Daintree River but within Douglas Shire Council boundaries (who is a holder of a current concessional ferry card) are visitor concessional tickets.

Each eligible cardholder will be entitled to purchase up to a maximum of 110 (one way) visitor tickets for use during a two year period. Visitor concessional tickets are non-refundable. The cost of a book of visitor tickets and their period of validity is detailed in *Council's* Fees and Charges.

The visitor concessional ticket must be presented to the Ferry Operator/Personnel prior to passage. Failure to do so will result in the full relevant fare being charged.

In addition to the above, a book of fifteen (15) visitor tickets for travel on the Daintree Ferry are to be supplied with each approved building permit at no charge to eligible residents north of the Daintree River.



Special Concession

Special concessions are available to an eligible ratepayer owning property north of the Daintree River or an eligible resident living north of the Daintree River but within Douglas Shire Council boundaries

This special concession will allow the cardholder to travel on the ferry in all types of vehicles except licensed passenger carrying vehicles including buses.

This special concession must be arranged at the time of purchasing their concessional card.

2. COOK SHIRE COUNCIL AND WUJAL WUJAL ABORIGINAL SHIRE COUNCIL COMMUNITY RATEPAYERS & RESIDENTS

Concessional travel will be offered as:-

- A universally barcoded card which includes the user's photograph.
- Expiratory date of cards is advised in Council's Fees and Charges, as is the cost of the card.

Eligibility Criteria

- Residents of the Wujal Wujal Aboriginal Shire Council area where residential status will be determined by proof that the person is on the electoral roll for the Wujal Wujal Aboriginal Shire Council.
- 2. Residents of the area of Cook Shire Council bounded generally by the Bloomfield River and the Black Mountain turn off onto the access road into Cooktown and who are either ratepayers from this area or on the electoral roll for the area.

3. TERMS AND CONDITIONS OF USE - ALL CONCESSIONAL CARD OR VISITOR TICKET TRAVEL

These terms and conditions relate to all eligible concessional cardholders herein after referred to as the "holder".

- i. The concessional card will entitle the holder to concessional travel on the Daintree Ferry as a pedestrian, on a bicycle or motorcycle, or in a vehicle with a load capacity of no more than 1.5 tonnes and to take a trailer up to 5 metres in length.
- ii. The concessional card covers the holder and any other persons while travelling together and in the same vehicle.
- iii. Concessional cards will not be accepted for travel when the vehicle being driven is a licensed passenger carrying vehicle.
- iv. Concessional cards are not transferable and it is the responsibility of the person to whom the card is issued to ensure their safe custody. Council reserves the right to refuse further concessional card sales to any person not complying with this requirement.
- v. Concessional cards are non-refundable.
- vi. To access concessional travel, concessional cards must be presented to the Ferry Operator/Personnel prior to passage. Failure to do so will result in the full relevant fare being charged prior to travelling on the ferry.
- vii. In the instance of card being lost or damaged, eligible cardholders will be able to purchase a replacement card at the full relevant price of ferry concessional cards at that time. This will apply regardless of the time remaining before concessional cards are to be renewed.
 - If a concession card is given to another person and it is attempted to use this card to obtain concessional travel, this card will be forfeited for a period of two weeks. During that time the defaulting card holder will be required to pay for all ferry travel. A register will be maintained of



- all transgressions and should be there a repeat occurrence that person's eligibility for concessional travel will be withdrawn entirely.
- viii. Council reserves the right to refuse further concessional cards to any person not complying with these terms and conditions of use.
- ix. Council also reserves the right to amend or vary these terms and conditions of use and/or prices quoted herein at any time.

4. FARE – LICENSED PUBLIC TRANSPORT BUSES (BUS LPT)

Businesses that satisfy the eligibility criteria will have access to the concessional bus fare to transport their passengers on the Daintree Ferry.

Eligibility Criteria

- The service being provided is a public bus transport function.
- A scheduled route will be advertised detailing the designated bus stops and times the service will be available. Council must be notified immediately of any changes to the scheduled route.
- Cost of the bus fare will be dependent on the customer's destination within the designated bus stops and pre-booking of travel is not a requirement.
- Buses will travel to the timetable advertised regardless of the number of passengers.
- It will be deemed that the bus is adhering to the timetable if it arrives at the ferry within half an hour (1/2 hour) either side of the designated time. Buses travelling on the ferry outside of these arrangements will pay the full relevant bus fare.
- Approval for the ferry concessional fare (Bus LPT) will be an annual requirement and applicants will need to furnish documentation to substantiate the eligibility criteria has been satisfied.
- Approval may be withdrawn should it be determined that the conditions associated with concessional fare are no longer being met.

5. SCHOOL TRIPS AND EXCURSIONS

Schools that satisfy the eligibility criteria will be provided with free travel on the Daintree Ferry for all school sanctioned trips and excursions.

Eligibility Criteria

- All schools who are members of the Queensland Department of Education Douglas Cluster. (These schools are Mossman State High School, Mossman State Primary School, Port Douglas State Primary School, Julatten State Primary School, Miallo State Primary School, Wonga Beach State Primary School, Daintree State Primary School and Alexandra Bay State Primary School);
- ii. Mount Molloy State School; and
- iii. St Augustine's Primary School Mossman.
- iv. Registered after school vocation programs operating within the same locality as the Queensland Department of Education Douglas Cluster.
- v. All schools, public or private, located within the Douglas Shire Council area (outside of the Queensland department of Education Douglas Cluster).

For these schools (with the exception of Alexandra Bay State Primary School) to qualify for free travel, they will need to provide Council the following:



- At least two working days prior to the trip or excursion the school must provide a letter on their letterhead, advising the date/s of travel and a precise description of the vehicle/s travelling across the ferry.
- Within a reasonable time after receipt of this letter, staff will make available prepaid tickets to the value required for travel across the ferry.
- The relevant school is to provide the name of the authorised person to collect tickets and when this person attends Council office to collect tickets, they must present photograph identification and sign for receiving tickets.
- The responsibility of the tickets will rest with the school and should these tickets be lost or stolen, replacement tickets will not be issued.

SERVICES PROVIDED TO COMMUNITY/NON-PROFIT GROUPS OR ORGANISATIONS NORTH OF THE DAINTREE RIVER

Organisations/Groups, which are providing a cost free service to community/non-profit groups, organisations or residents that are based north of the Daintree River, but within the Douglas Shire Council, are to be provided with free travel across the Daintree Ferry.

Eligibility Criteria

- The organisation/group providing the service (service provider) will be required to furnish Council with a letter; on letterhead, advising the following:-
 - (a) Whom they are providing the service to; and
 - (b) That the service is at no cost; and
 - (c) A precise description of vehicle/s travelling across the ferry; and
 - (d) The date/s of travel; and
 - (e) The authorised person who will be collecting prepaid travel tickets.
- The organisation/group receiving the service (service recipient) will be required to confirm in writing the name of the service provider and that the service is provided free of cost.
- All letters must be provided to Council at least two working days prior to travel to allow staff reasonable time to process the request.
- The relevant authorised person will be required to produce photograph identification and sign for receipt of prepaid tickets.
- The responsibility of the tickets will rest with the service provider and should these tickets be lost or stolen, replacement tickets will not be issued.

7. AUSTRALIAN DEFENCE SERVICES

All Australian Defence Force personnel whilst travelling on official Defence Force operations/business will be provided transport on the Daintree River Ferry at no cost. Relevant identification will be required prior to passage being granted.

8. REGISTERED CHARITIES WITHIN DOUGLAS SHIRE COUNCIL UNDERTAKING FUNDRAISING EVENTS WHICH NECESSITATE TRAVEL ON THE FERRY

The Chief Executive Officer has delegated authority to provide community assistance by way of concessional travel on the Daintree River Ferry. This assistance is only for registered Charities operating in the Douglas Shire Council area that are undertaking a specific event that requires members/event participants to travel in convoy on the ferry. Assistance will only be provided



upon receipt of a written request for a specified event (but limited to one request per organisation, per financial year).

This policy is to remain in force until otherwise determined by Council.


