

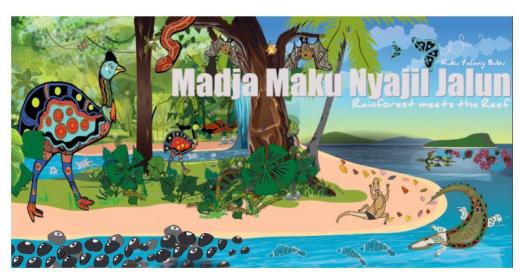

3. MAYORAL MINUTE

"That Council:

- 1. Endorses Council staff to cease the current works on the Dog Off Leash Area at Hutchings Park;
- 2. Resolves to use the funds to contribute towards installing decorative lighting on Macrossan Street; and
- 3. Requests Council staff to investigate sites for an alternative location for a Dog Off Leash Area in Port Douglas, and bring back a report to Council for consideration in the 2019/20 Capital Works Program."

BACKGROUND INFORMATION

In the 2018/19 Capital Works Program adopted in June 2018, \$145,000 was allocated for the Dog Off Leash Area at Hutchings Park, Port Douglas. Community engagement was undertaken which indicated support, but not from those living closest to the park. Since then a significant number of residents closest to the proposed dog park have expressed concern and requested that Council "stop the 'trial run", and "abandon the idea of dog run in this park".

It is recommended to put the project on hold and revisit in the 2019/20 financial year at a different location.

Council issued a media release on 28 March 2019 advising the community that Council would fund the 'Light up Port' project to boost the town's ambience and reinvigorate business confidence in the region.

It is recommended that the funding allocated for the Dog Off Leash Area contribute to the Macrossan Street lighting project. The garden revamp and lighting project will present a more vibrant Port Douglas for both visitors and locals. It will boost the town's ambience by transforming Macrossan Street into a night friendly pedestrian thoroughfare.

Douglas Chamber of Commerce is also keen to light up Macrossan Street and generate business confidence after a challenging wet season.

More colourful garden beds, more trees and improved footpaths were some key improvements requested by residents through the Macrossan Street survey. Improved street lighting was also a popular suggestion.

Council crews will also be revamping garden beds at the Esplanade end of Port Douglas as part of a green splash for the main street and then move their way up Macrossan Street to make the street fresher and more vibrant.

The proposed reallocation of funds allows for the Macrossan St improvements to commence now, rather than waiting for the 2019/20 budget adoption.

5.2. EXPIRING TRUSTEE PERMIT FOR PROVISION OF COAST GUARD SERVICES - LOT 51 ON SP288958, WHARF ST PORT DOUGLAS

- Offers a Trustee Permit to the Public Safety Business Agency (PSBA) on behalf of Queensland Fire and Emergency Services (QFES) over Lot 51 on SP288958, Wharf Street Port Douglas, for the purpose of providing marine rescue services covering an area from Ellis Beach to the Hope Islands and for the storage of flares and associated flammable materials:
 - i. for a term of 12 months commencing from 1 May 2019 and expiring 30 April 2020, or until such time as the dispute between the former Flotilla QF10 volunteers and its parent body the Australian Volunteer Coast Guard Association (AVCGA) is resolved and a trustee lease is formally in place, whichever is the sooner;
 - ii. utilising the terms and conditions of the Standard Terms Document registered under dealing number 713488911 and also the State's Mandatory Standard Terms Document registered under dealing number 711932933; and
 - iii. rent for the term of the Trustee Permit to be waived
