3.1. DEPUTATION - MOSSMAN AGRICULTURAL SERVICES PIG DAMAGE IN SUGARCANE PRESENTATION TO COUNCIL

Mossman Agricultural Services (MAS) presented a deputation updating Council on the challenges and impacts of feral pigs damaging sugar cane.

MAS raised concerns over the increased impacts of feral pigs on Douglas Shire's Sugar Cane Industry.

Over the past few years, pigs have become an increasingly larger problem, with annual cane yield losses resulting from pig damage in the hundreds of thousands of dollars. MAS works directly with growers and hears almost daily reports of pig damage and the inability of growers to control their numbers effectively.

Feral pigs do not pay heed to boundaries, they will travel across multiple properties in search of food, water, and cover. Managing feral pigs is a shared responsibility between all levels of government, communities, industry, and landholders. A collaborative program with all stakeholders working together delivering a locally coordinated and aligned approach would be the most effective.

Cr Kerr thanked Mr Simon Engdahl (Mossman Agricultural Services), and Cane Farmers Mr Raldini and Mr Murday for the presentation to Council.
