### **5.5. TENDER FOR MOSSMAN SPLASH PARK**

### RECOMMENDATION

## **That Council:**

- 1. Resolves to award Contract WO5843 Mossman Splash Park Design & Construct to Urban Play Pty Ltd (ABN 87 569 981 10) for \$150,659.30 (GST exclusive) for water play equipment supply; and
- Resolves to award Contract WO5843 Mossman Splash Park Design & Construct to Aquatic Project Solutions Pty Ltd (ABN 66 625 525 813) for \$405,935.18 (GST exclusive) for splash pad, water treatment plant, hydraulic supply & install and water play equipment install; and
- 3. Delegates authority under s 257 of the *Local Government Act 2009* to the Chief Executive Officer to negotiate, finalise and execute any and all matters in relation to this contract.

### **EXECUTIVE SUMMARY**

Douglas Shire Council has obtained a grant to install a splash park in Mossman. A tender was released to the open market and no conforming tenders were received.

Council officers were able to negotiate with the one non-conforming tenderer to provide a suitable quote for the project.

## **BACKGROUND**

Council was successful in obtaining a \$1.5M grant for splash parks in Port Douglas and Mossman from the Queensland Government.

As such, Douglas Shire Council requires a contractor to design and construct a splash park at the Mossman pool.

### **COMMENTS**

Council issued an open tender invitation through Vendor Panel for the WO5843 – Mossman Splash Park Design and Construction. The Vendor panel reference number is VP306280.

The tender invitation was Australia wide and called for interested contractors to provide designs and subsequent construction up to a maximum amount.

There were no conforming submissions received and only one non-conforming submission, which was for supply of equipment only.

Council officers commenced discussions with the supplier, Urban Play that had made a submission.

Urban Play in conjunction with an installer/builder Aquatic Project Solutions that they have partnered with in the past, were able to provide pricing for two options for the design, supply and installation of a splash park facility.

Option one was for a fully installed system, whilst option two was for a staged system, whereby a basic install was provided and later, further water play equipment could added. There was only approximately \$20,000 difference between the two options.

The relevant Council departments recommend that option one be selected.

Once a contracted is awarded, officers will work with the contractor to optimise and finalise the technical details of the project such as power requirements.

### **PROPOSAL**

# That Council:

- Resolves to award Contract WO5843 Mossman Splash Park Design & Construct to Urban Play Pty Ltd (ABN 87 569 981 10) for \$150,659.30 (GST exclusive) for water play equipment supply; and
- Resolves to award Contract WO5843 Mossman Splash Park Design & Construct to Aquatic Project Solutions Pty Ltd (ABN 66 625 525 813) for \$405,935.18 (GST exclusive) for splash pad, water treatment plant, hydraulic supply and install and equipment install; and
- 3. Delegates authority under s 257 of the *Local Government Act 2009* to the Chief Executive Officer to negotiate, finalise and execute any and all matters in relation to this contract.

#### FINANCIAL/RESOURCE IMPLICATIONS

The proposed engagement of suppliers exceeds the current budget for the project.

However, there is a \$1.5M total grant from the Queensland Government for the delivery of splash parks at Mossman and Port Douglas and it is proposed to reallocate the necessary budget shortfall amount from the Port Douglas project allowance.

A variation to the funding agreement will need to be approved by the Department of State Development, Infrastructure, Local Government and Planning.

## **RISK MANAGEMENT IMPLICATIONS**

As described above, Council has obtained an external grant for the Mossman Splash Park and acceptance of this proposed resolution will enable Council to fulfil its grant obligations.

By not resolving to award the Contract, Council will not meet the funding agreement conditions and the funding will need to be handed back to the Department of State Development, Infrastructure, Local Government and Planning.

#### SUSTAINABILITY IMPLICATIONS

**Economic:** Council has not provided this type of service to the community before,

so does not have a detailed understanding of the operational costs of such a facility. Evidence from other Council's for similar sized splash parks indicate costs up to \$100,000 per annum. However, these costs will be somewhat mitigated by locating the facility at the pool complex, where resourcing for the pool can be extended to include the splash

park, for example cleaning/ garden maintenance, etc.

**Environmental:** Nil as it is located in the existing pool complex

Social: The splash park is expected to provide well-being and entertainment

value for a variety of users, such as small children, disabled persons

and the family groups.
