RECOMMENDATION

That Council notes the results achieved to date and the future projections contained in the 2014 NDRRA PCG Monthly Report 11 – November 2015.

EXECUTIVE SUMMARY

Monsoonal flooding between 7-9 February 2014 and during Tropical Cyclone Ita on 11-14 April, 2014 caused extensive damage to existing infrastructure within the Shire. This report details progress to date concerning the restoration program under the Natural Disaster Relief and Recovery Arrangements.

Progress to date consists of:

Total Funding Approved to date: \$22,533,297

- Works complete 87.3%
- Income to date \$12,058,091
- Expenditure to date \$19,855,871
- Expenditure into local economy for month of November \$610,000

BACKGROUND

Between 7-9 February 2014 monsoonal flooding occurred within the Douglas Shire and was followed between 11-14 April 2014 by Tropical Cyclone Ita. Both these events caused extensive damage to Council infrastructure, mainly roads, within the Shire.

Council's Management Team set up a Project Control Group to manage the Natural Disaster Relief & Recovery Arrangements (NDRRA) and assist in the mitigation of project delivery risk to Council.

In accordance with the NDRRA requirements, Douglas Shire Council submitted a number of funding applications to restore the damaged infrastructure and Council has been successful in securing substantial funding.

Current funding arrangements for the completion of the restoration for the damaged assets require the completion of all works by June 2016.

The attached report provides an update of the progress to date with the restoration program.

COMMENT

Council has engaged a Project Engineer, Project Finance Officer and a Traffic Management Officer to assist in the management of projects associated with the NDRRA, including the control of finances and acquittal of funding associated with the restoration of essential assets. Council officers continue to work with officers from the Queensland Reconstruction Authority, consultants, contractors and the community to ensure the successful delivery of all works.

In light of enquiries from the community and Councillors concerning recent NDRRA road repair performance issues during the Christmas period, the opportunity to update stakeholders has been taken in this Council report, though it would normally be presented in the December report. A technical explanation will be provided then, but in summary:

- 1. Concerns about the gravel pavement material sourced from one quarry were raised by the Contractor, Superintendent and Council Officers. This information has been highlighted in previous progress reports.
- 2. There were unacceptable and acceptable performing roads containing the gravel material in 16 locations. Reworking including adding of additional material was undertaken by the Contractor at its cost on some roads. A wait and see approach was taken for the roads that were performing adequately.
- 3. Over 750 mm of rain (in some areas over 1000mm) occurred prior to and directly after Christmas.
- 4. Four of these roads (of which three had performed adequately to this point) became difficult to traverse in 2wd vehicles.
- 5. Council officers inspected the roads and given the continuing rain, impact of construction vehicles on the roads and the lack of available of replacement gravel decided that dry weather was required before removing the unsuitable gravel. This began on 4th January by the Contractor.
- 6. The Contractor has committed to remove and replace all the unsuitable gravel, including on those roads that did not report problems, at its cost. This is expected to take until the end of January 2016, weather permitting.
- 7. Officers have contacted all known concerned community members to advise of the action proposed and underway, including undertaking site visits and contacting residents during the Christmas/New Year while Council was closed.
- 8. Detailed advice has been provided to Councillors.

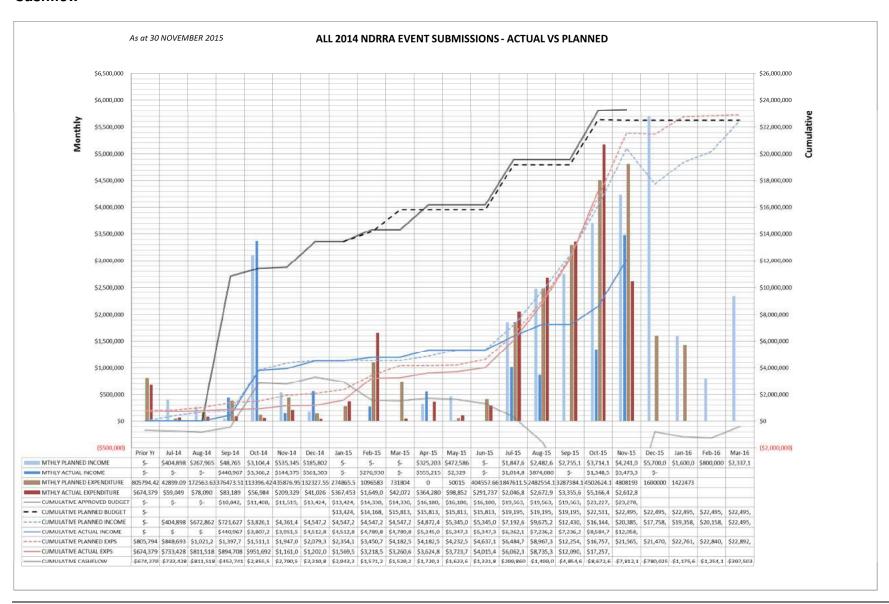

8 QUALITY ASSURANCE

- Incidents to report
 - Insitu material testing for gravel material compliance results received indicating non- compliance from one quarry source. 16 roads constructed using this quarry source with 14 roads showing some form of non-compliance. Five roads deemed unacceptable in current configuration and to be repaired or gravel material replaced. Remaining roads to have extended defects period to monitor performance over wet season, with opportunity for further rectification if required.

9 COMMUNITY LIAISON

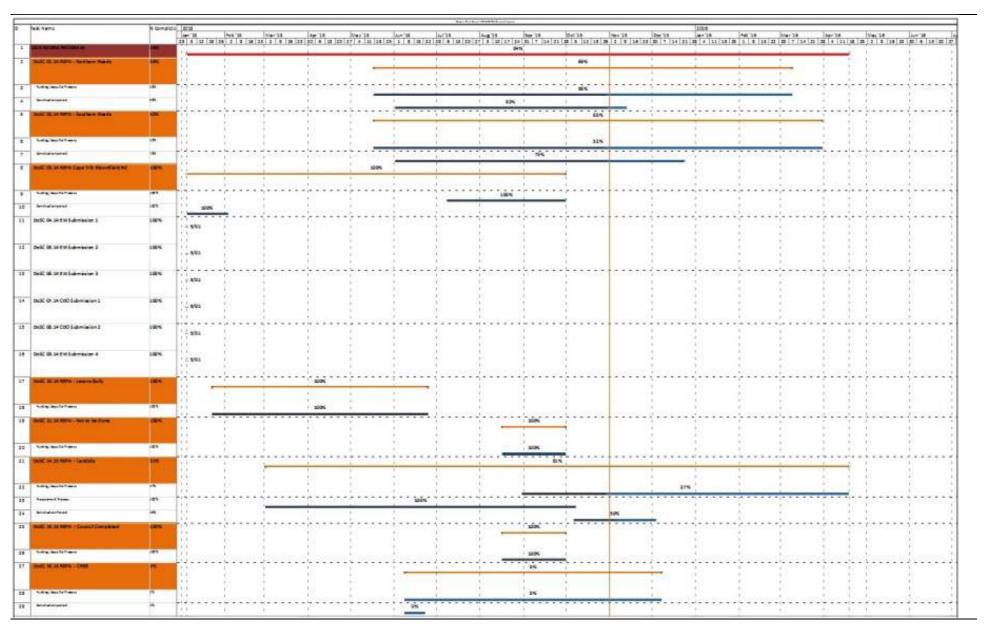

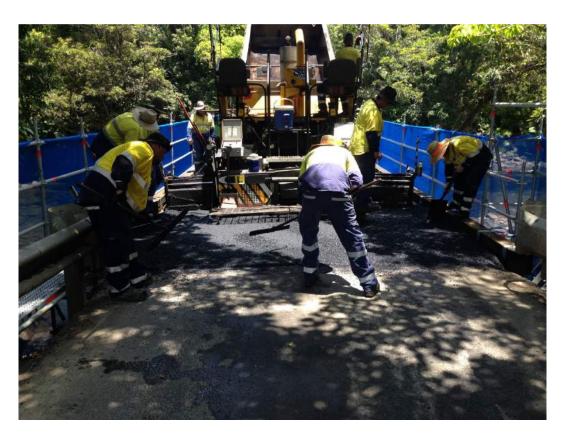
