


Figure 1. – Site Plan

RECOMMENDATION

That the Office of Liquor & Gaming Regulation, Department of Justice & Attorney-General, be advised that Council does not object to the removal of Condition LL003 from the Commercial Hotel Licence for Cow Bay Pub Pty Ltd, 1480 Cape Tribulation Road, Cow Bay, also described as Lot 458 on RP738178. The removal of the condition has no bearing on the town planning approval associated with the site.

INTRODUCTION

A request for Council's comment has been submitted by the Department of Justice and Attorney-General, Office of Liquor and Gaming Regulation, for the Cow Bay Hotel, located at 1480 Cape Tribulation Road, Cow Bay, and described as Lot 458 on RP738178. A copy of the request is attached as *Attachment 1*.

The original request was received on 15 April 2019. Comments are due to the Department by 30 April 2019 as required by section 117 of the Liquor Act 1992. Given comment can only be provided late due to Council meeting dates, the advice may not be considered. Officers from the Department have been advised that the comment will be late.

Proposal

The current Commercial Hotel license includes conditions as detailed in Attachment 1. A request by the applicant has been made to remove condition LL003- *Persons under the age of 18 years shall not be in areas of the licensed premises where entertainment is being conducted at any time after 10:00pm.*

Planning Scheme Requirements

The land is included within the Conservation zone of the 2018 Douglas Shire Planning Scheme version 1.0. There are no planning concerns with regard to the approved use on the site. The request to change the subject condition has no bearing on the Material Change of Use development Approval for a Hotel existing over the site.

Discussion/Comments

Comments in relation to the proposed condition were received from Council's Community and Economic Development Officer and Council's Environmental Health Officer.

Council is afforded the opportunity to comment on the reasonable requirements of the public and/ or object to the grant of the request.

Any comments or objections should include the full particulars the grounds upon which the objection is made and the facts, evidence or reasons upon which it is based.

The initial consideration by officers is the question of why such a request would be made. The applicant has advised that the request to remove the condition is to allow for families to continue to utilise the venue after 10pm. The applicant advises that the Cow Bay Hotel is set in the context of the small Daintree coast community and is utilised for many community based fund raising events which the community benefits from.

The premises host events which raise funds for the local primary school, medical centre, Leukaemia foundation and individual community members in need. The applicant advises that the subject condition is often in conflict with the spirit of the community and that the hotel provides a community hub. For example, conflict would arise where a band is put on for an event where, after 10pm, persons under the age of 18 are required to leave the premises.

This would generally require that a whole family attending an event with live entertainment, which may be for fund raising, would need to leave the premises.

The applicant has advised that in seeking to have the condition removed from the Hotel license, that the requirement for the management of minors will be removed from the hotel. The Hotel *Risk Assessment Management Plan* (RAMP), required as part of the liquor license, will be updated to ensure that there is sufficient management of small children on the premises.

The Office of Liquor and Gaming regulation has advised that this type of condition is no longer imposed on Commercial Hotel licenses. Rather than apply for a new license, the applicant has requested to remove the condition which would allow persons under 18 to be present where entertainment is being provided up until 12pm consistent with the licensed trading hours for the premises.

Council's Community & Economic Development Officer

The request for comment was forwarded to the Community and Economic Development Officer to provide comments on behalf of the CEO Unit.

The Community and Economic Development Officer has no objection to proposal as it is a relatively old condition no longer imposed on new licenses.

Environmental Health Officer

Environmental Health & Regulatory Services has assessed this application and offers no objection to the proposal, as the operators have obtained a food business license to prepare and sell food.

COUNCIL'S ROLE
