## **EXECUTIVE SUMMARY**

Motions have been called for the 2018 LGAQ Annual Conference. The motion detailed in Attachment 1 has been submitted for consideration by Councillors.

The proposed motion is:

That the LGAQ make vigorous representations to the Queensland State Government urging it to immediately cease any considerations to supporting, financially or by any other means, and either directly or indirectly, the proposed Carmichael Coal Mining Project by Adani in the Galilee Basin.

## **BACKGROUND**

The LGAQ Annual Conference provides an opportunity for Queensland councils to come together once a year to debate issues of importance to their local communities.

The debated motions also provides input into the LGAQ policy agenda and informs priorities for local government in the State.

# **COMMENT**

The motion to be submitted to the LGAQ Annual Conference will seek support from the LGAQ to request the State Government to stop any further actions and considerations regarding the Carmichael Coal Mining Project by Adani in the Galilee Basin.

Council has discussed this matter previously when it determined a policy position to oppose any proposals for coal mining in the Galilee Basin at its meeting held 19 September 2017.

The submission to LGAQ aims to build further momentum and support for this very important issue.

In order for this motion in Attachment 1 to be submitted for consideration at the LGAQ Conference Council must first pass a resolution in support of the motion. It will then be submitted via the online portal by Friday 24<sup>th</sup> of August.

# **Background**

It is the Council's understanding that as recently as early June 2018 the State Government was considering covering the estimated \$100 million upfront costs of road access for Adani's Carmichael coal mine in the Galilee Basin.

Furthermore, the mine, once operational, will draw billions of litres of water from the Great Artesian Basin completely free of charge because, as the Council understands it, the Queensland Government has granted Adani unlimited water removal rights for 60 years, plus approval for a floodwater harvesting 10 gigalitre dam.

The negative impacts of the Carmichael coal mine proposal are obvious and succinctly summarised in the following policy position determined by the Douglas Shire Council on 19 September 2017:

"The Douglas Shire Council opposes any proposals for coal mining in the Galilee Basin, in particular current proposals by the Adani Group.

The potentially significant negative economic impacts on the future wellbeing of the Great Barrier Reef caused by shipping, maintenance of port facilities and climate change from the burning fossil fuels is unacceptable. There is not only an environmental imperative to protect the Great Barrier Reef from the effects of continuing use of fossil fuels, particularly coal, but an economic one as well, especially for the Douglas Shire.

The Great Barrier Reef represents an estimated \$6.4 billion annually to the Australian economy, \$3.9 billion of which is attributed to the Queensland economy. The Reef supports 64,000 jobs nationally, the vast bulk of which are in Queensland. This makes the Reef a larger full-time "employer" than many of Australia's corporate giants, such as Qantas, Telstra and the National Australia Bank.

The Great Barrier Reef, together with the Daintree National Park, is the backbone of the Douglas Shire economy, representing 80% of economic activity within Douglas annually. In Douglas, there is extensive private investment and confidence in this billion-dollar vital industry, with new and expanded dive adventures and diversification in overall reef experiences. It is critical this is not put in jeopardy.

The following are unacceptable risks to the future wellbeing of the Great Barrier Reef and the resultant significant negative impacts on the Douglas Shire economy:

Further coal mining activity will only exacerbate these effects.</li> <li>Significantly increased maritime activity within the Great Barrier Reef marine park as a consequence of shipping coal for export which is delivered to Abbot Point from the Galilee Basin will represent further potential threats to the wellbeing of the reef into the future due to the risks of vessels potentially colliding with the reef;</li> <li>The requirement for dredging at Abbot Point Port facilities to accommodate coal, shipping vessels will present significant risks to the health of the Great Barrier Reef as a consequence of sediment stirred up by dredging activities;</li> </ul> |
