#### **EXECUTIVE SUMMARY:**

This report identifies a number of fees and charges that were inadvertently omitted from the Fees and Charges Schedule adopted by Council at the Special Meeting held on 15 May 2015.

## **BACKGROUND:**

In conjunction with the preparation of the annual budget Council is required to adopt a schedule of fees and charges to be applied for each financial year. Should circumstances warrant, new fees can be introduced or fees amended throughout the year.

#### **COMMENT:**

Unfortunately when the Fees and Charges Schedule 2015 – 2016 was presented to Council for adoption a number of fees and charges were inadvertently omitted. These fees and charges are contained in the addendum attached to this report and consist of existing fees and charges that have been increased by the agreed 3.6% (subject to rounding to the nearest 5 cents) for the 2015/16 financial year.
