#### RECOMMENDATION

That Council endorses the formal submission to the Advance Queensland 10-Year Roadmap for the Screen Industry.

#### **EXECUTIVE SUMMARY**

The Queensland Government is committed to growing the strong and rapidly evolving screen industry in Queensland. The Premier and Minister for the Arts, Annastacia Palaszczuk MP opened consultation on the Advance Queensland 10-Year Roadmap in October 2017, with formal submissions closing 31 December 2017 (extended from the original 8 December closing date.) Council has prepared a formal submission in response to the draft Roadmap.

#### BACKGROUND

The Advance Queensland 10-Year Roadmap for the Screen Industry consultation paper has been developed to start the conversation about how to grow Queensland's screen industry, widely recognised for its growing economic and cultural contribution to the state. In addition to film and television, 'screen' now includes app development, interactive games and content, online digital content and subscription video on demand platforms.

Screen industry stakeholders, established and emerging practitioners and community input was invited on how to build on Queensland's existing strengths and capitalise on the opportunities to grow the industry, create jobs and ensure Queensland stories continue to be heard.

Originally the consultation was to close on 8 December 2017, but has been extended to 31 December 2017.



It is important that regional network lists are created and maintained to ensure growth and development of the screen industry outside of South East Queensland.
- Maximising exposure with all Film Location Databases shared and readily accessible on all Australian and State-based screen industry websites and promoted throughout their information networks.

### How opportunities for Queensland startups and small-to-medium enterprises (SMEs) can be maximised to participate in supply chains for the global screen industry

- Providing local governments with information (eg website links, contacts and resources) on how businesses go about participating so information can be distributed at a local level
- Providing opportunities for Queensland startups and SMEs to be included on comprehensive and lists of professional businesses and individuals which are able to meet the needs of the Screen Industry.

# Potential 'spill-over' benefits from the development of technologies in the screen industry to other industries in Queensland (and vice-versa)

 Transferring skills and technology suited for the Screen Industry to other areas of the creative arts; helping build and grow the capacity and skills of individuals and artistic-based organisations and businesses; and supporting regional festivals and community events.

# Actions the Queensland Government could undertake over the next 10 years to support the screen industry in Queensland

- Facilitating and managing the development of professional networks so that local industries and government are aware of all opportunities around the industry
- Promoting a Film Festival Trail marketing the range of film festivals across the State
- Marketing nationally and internationally, a centralised portal of Film-friendly Councils, and what each offers (fee waive/reductions, previous experience hosting movies, range of weather conditions/scenes offered, local businesses in their Shire that offer accommodation packages, free/reduced rates for office space, industrial sheds)
