6.3. NOTICE OF MOTION - RECONFIGURATION OF FACILITIES DIWAN CLINIC

NOTICE OF MOTION:

I hereby give Notice of my intention to move the following Motion at the Council meeting scheduled for Thursday 28th January 2016:-

"That Council resolve to:-

- (i) Confirm approval for the Cow Bay Clinic to be relocated into the main Community Facilities Building at Diwan, with the Community facilities and internet access facilities being relocated into the existing Clinic annex adjacent to Community Facilities building,
- (ii) Approve building modifications, including the installation of ceiling insulation material to facilitate the immediate location of all clinic facilities into one building, with all required relocation works being funded by Queensland Health."

BACKGROUND:

On 11th May 2015 the Friends of the Foundation wrote to Council requesting the relocation of all Clinic facilities into the Community Building at Cow Bay on the basis the community facilities, including internet services, would be relocated into the current Clinic annex.

On 11th January 2016 Councillor Clarke and I visited the area North of the Daintree to me with residents, ratepayers and small business owners, and while visiting the Clinic found that Council approval is still being awaited to finalise the rearrangements.

The current situation is the whole project is in Limbo awaiting a response from Council and this is the reason for the submission of the Notice of Motion.

The letter sent for the attention of the CEO and Councillors (although I cannot recollect having received a copy) is attached for information.

OFFICER'S COMMENT:

Upon receipt of correspondence from Friends of the Foundation, enquiries were undertaken by Council staff with Queensland Health to confirm relocation requirements. As these works were of a minor nature, approval in principle in writing was issued to Friends of the Foundation and Queensland Health on 8 July 2015.

In mid-December 2015, staff received the formal proposal from Queensland Health of the modifications/relocation works to be undertaken and approval has subsequently been issued in January 2016 for this work to commence.
