

- 2. advises DNRME that it has no objection to the proposed application for permanent partial road closure over part of Heritage Lane, Craiglie adjoining Lot 12 on N157447, subject to the following condition:
  - the applicant must amalgamate the proposed road closure area Lot A on AP21268 into the adjoining Lot 12 on N157447; and
- 3. delegates authority under section 257 of the Local Government Act 2009 to the Chief Executive Officer to finalise any and all matters associated with the application."
