5.5. LOCAL GOVERNMENT LEVY READY GRANT PROGRAM

RECOMMENDATION

That Council resolves to:

- 1. Endorse the funding application to the State Government's 'Local Government Levy Ready Grant Program' for \$36,791 (GST Exc) for the Killaloe Waste Disposal Facility Infrastructure Upgrade Project; and
- 2. Contribute \$15,767 (GST Exc) (30 per cent) towards the eligible project costs; and
- 3. Delegate authority to the Chief Executive Officer in accordance with Section 257 of the *Local Government Act 2009* to finalise any and all matters associated with the grant application.

EXECUTIVE SUMMARY

The Local Government Levy Ready Grant Program (LGLRGP) provides financial assistance to support Councils to undertake any necessary infrastructure works at waste disposal facilities required to implement the Queensland Government Waste Disposal Levy commencing 4 March 2019.

The program offers a subsidy up to 70 per cent of eligible project costs, with a total pool of \$5 million for projects that facilitate accurate collection of the levy, ensure adequate security and operational site controls and comply with environmental authority and regulatory requirements.

This report seeks Council's endorsement of the funding application and approval to contribute the required 30 per cent towards eligible project costs.

BACKGROUND

The State Government will introduce a waste disposal levy in March 2019, initially set at \$70 per tonne of general waste sent to landfill. LGLRGP provides financial assistance for necessary infrastructure works at waste disposal facilities required to implement the levy.

Project proposal submissions opened 31 August and closed 5pm Friday 12 October 2018.

Killaloe Waste Disposal Facility ("Killaloe") is the largest waste facility in the Shire, receiving approximately 8,500 tonnes of waste from Council's remote transfer stations and domestic and commercial sources.

The proposed elements of the project for the Killaloe facility include:

- **Security**: lighting; CCTV for the landfill; and a barrier at the landfill access in accordance with the legislation;
- **Traffic control:** 5 x give way signs; updates to the Traffic Management Plan and line marking:
- Signage: information and new fees and charges signage; and
- Software upgrades for capturing weighbridge data.

COMMENT

Under the program guidelines funding may be prioritised for projects where Local Governments:

- Have waste disposal facilities with environmental authorities to dispose of more than 5.000 tonnes of waste:
- Are situated in the levy zone (Douglas Shire is in the zone);
- Have limited capacity to self-fund projects.

Council's Executive Leadership Team supported a submission to the program for infrastructure projects at the Killaloe site. As these projects are not budgeted for in 2018/19, as the levy was announced after the budget was adopted, Council approval is sought to commit funds towards eligible project costs.

PROPOSAL

The proposal is for Council to endorse the funding application to the State Government's *Local Government Levy Ready Grant Program* for \$36,791 (GST Exc) for the Killaloe Waste Disposal Facility Infrastructure Upgrade Project and approve Council's contribution of \$15,767 (30%) towards eligible project costs.

FINANCIAL/RESOURCE IMPLICATIONS

The total eligible project costs are estimated to be \$52,558 (GST Excluded), with Council seeking 70% of this cost under the grant. The required Council contribution to complete this project will need to be incorporated into the 2018/2019 capital budget should the funding application be successful.

RISK MANAGEMENT IMPLICATIONS

The Queensland Government Waste Disposal Levy is to be implemented and will require additional expenditure by Council to administer. Consequently, Council would have to fund a 100% of these costs whereas under the application for the *Local Government Levy Ready Grant Program* there is a potential to only have to fund 30% of costs.

SUSTAINABILITY IMPLICATIONS

Economic:

Infrastructure requested under this grant is required in order to collect the correct information for the landfill levy, ensuring Council's levy liability is accurate. This infrastructure is also expected to prevent incorrect disposal in contravention of the legislation which carries heavy penalties.

Environmental: Infrastructure requested under this grant is required for implementation

of the waste levy which will reduce the incentive to dispose of waste to

landfill and encourage sorting of waste for reuse and recycling.

Social: Infrastructure requested under this grant includes improvements to

traffic management and information signage at Killaloe Transfer Station which is expected to assist customers while visiting the facility and

improve safety for users of the site.
