RECOMMENDATION

That Council resolves to:

- adopt Level 3 and 4 Water Restrictions as detailed in Schedule 1 of this report for all water supply schemes in the Douglas Shire in accordance with sections 41 and 53 of the Water Supply (Safety and Reliability) Act 2009 (the Act);
- 2. delegate to the Mayor and Chief Executive Officer (CEO) the authority to implement, if required, all Water Restrictions as described in Schedule 1 of this report in accordance with sections 41 and 43 of the Act; and
- 3. adopt amended Schedule 1 as attached.

EXECUTIVE SUMMARY

Council is registered as a drinking water service provider under the Water Supply (Safety and Reliability) Act 2008 (the Act). Section 41 (1) of the Act gives a water service provider the power to restrict:

- a. the volume of water taken by or supplied to a customer or type of customer; or
- b. the hours when water may be used on premises for stated purposes; or
- c. the way water may be used on premises.

The water service provider (WSP) may impose a restriction under subsection (1) (a **service provider water restriction**) only if-

- a. there is an urgent need for the service provider water restriction; or
- b. the available water supply has fallen to a level at which unrestricted use of the water is not in the public interest; or
- c. the service provider has a reasonable and comprehensive strategy for demand management for water and the restriction is essential to ensure the aims of the strategy are met.

BACKGROUND

In the event of continuing prolonged dry weather, the impact on water levels in all supply intakes, the ability of the water treatment plants to meet demand (particularly when experiencing high tourism numbers in the region) can become critical. Not withstanding the recent rainfall in the week beginning (16 October 2017) Council must ensure it has a reasonable and comprehensive strategy for demand management.

In 2014, Council adopted Level 1 and 2 Water Restrictions to assist in the management of supply and to ensure delivery of essential water.

It was always intended to create additional restriction levels to enable Council to be better prepared should dry weather conditions continue to escalate and adversely impact on the available water supplies. As part of the Water Resilience program works undertaken during 2016-2017, higher level restrictions were assessed, particularly with consideration of water usage trends in recent years, and the requirement to implement water restrictions every year since Council de-amalgamated from Cairns Regional Council.

Level 2 water restrictions are currently in place as the Douglas Shire is experiencing a prolonged dry weather period, as well as a continued high demand for reticulated water supply due to a very busy tourist season. Adoption of the additional restriction levels, and delegation to the Mayor and CEO for all levels of restriction, will assist in reducing water usage to that of an essential nature should conditions prevail and measures be required to be implemented to further reduce consumption.

COMMENT

It is the opinion of the authors that, in accordance with Section 43 (2) of the Act, the conditions for restricting water will enable Council to act if:

- a. there is an urgent need for the higher level water restriction due to prolonged dry weather:
- b. water supply intake levels drop to a level that cannot ensure supply can continue to be met:
- c. the available water supplies fall to a level at which unrestricted use of water is not in the public interest; and
- d. the use of water for non-essential needs, and falling intake levels of the supply creeks, mean that Council will exceed the maximum extraction limits.

PROPOSAL

It is proposed that council, as the WSP, resolve to:

- adopt Level 3 and 4 Water Restrictions as detailed in Schedule 1 of this report across all water supply schemes in the Douglas Shire in accordance with sections 41 and 43 of the Act;
- 2. delegate to the Mayor and Chief Executive Officer (CEO) the authority to implement, if required, all Water Restrictions as described in Schedule 1 of this report and in accordance with sections 41 and 43 of the Act; and
- 3. adopt amended Schedule 1 as attached.

FINANCIAL/RESOURCE IMPLICATIONS

There may be some impact on Council's income that is derived directly from water consumption. As each water restriction is activated, water consumption will fall thus impacting income.

There will be an impact on Council's staff in patrolling and enforcing water restrictions when they are implemented. Theses impacts will be closely monitored and the necessary actions taken to ensure that resources are appropriate to the situation, particularly where dry weather continues.

RISK MANAGEMENT IMPLICATIONS

Council is responsible for providing a reliable water supply to its customers. Water restrictions are necessary to ensure that the consumption does not outweigh supply, and the water infrastructure can cope with the level of demand. Without effectively monitoring and managing water, the Shire could face serious water supply issues, which would have an adverse impact on water customers. The introduction of Level 3 and 4 Restrictions as and when required will assist Council in ensuring that customers are not adversely impacted in regards to the supply of water.

SUSTAINABILITY IMPLICATIONS

Economic: There is expected to be some loss of income to Council as a result of

reduced water consumption during a restricted period.

Environmental: No environmental impacts are expected as a result of implementing

water restrictions.

Social: When required, the implementation of water restrictions is necessary

to ensure the supply of essential use water to customers. If water supply issues are not addressed, and Council is put in a position where the supply to customers is compromised, there will be significant impacts on the communities connected to the water

supply.

COUNCIL'S ROLE

Council can play a number of different roles in certain circumstances and it is important to be clear about which role is appropriate for a specific purpose or circumstance. The implementation of actions will be a collective effort and Council's involvement will vary from information only through to full responsibility for delivery.

The following areas outline where Council has a clear responsibility to act:

Asset-Owner Meeting the responsibilities associated with owning or being the

custodian of assets such as infrastructure.

Fully-Responsible Funding the full cost of a program or activity

Regulator Meeting the responsibilities associated with regulating activities

through legislation or local law.

To assist in interpretation, the following definitions shall apply:

"Active playing surface" shall mean a grass or synthetic area for playing sports such as a tennis court, turf cricket pitch, running track, hockey pitch, bowling green, croquet green, golf green or tee, football, soccer, volleyball, netball or baske

"Alternate days" shall mean designated days of water use, such that where permitted in Schedule 1:

- (a) Properties with an even street number may water on Tuesday, Thursday and Saturday;
- (b) Properties with an odd street number may water on Wednesday, Friday and Sunday;
- (c) Properties without a Council prescribed street number may water on Wednesday, Friday and Sunday.

NO WATERING IS PERMITTED ON MONDAYS

"Authorised Officer" shall mean a person authorised by Douglas Shire Council to exercise the powers of an authorised person under the Water Act and State Penalties Enforcement Act.

"Commercial market garden or plant nursery" shall mean land used primarily for the growing of plants including produce and turf for sale or distribution for profit.

"Domestic purposes" shall mean potable water taken from the water supply system inside any premises for drinking, cooking, washing persons and clothes, use for dishwashing, or cleaning, heating and cooling a building, and sanitation purp

"Drip system" shall mean a watering system that restricts the flow of water to a nominal amount, such as an emitter, and applies water directly to the soil around plants, and must incorporate a manual or automatic timer in operational conc

"Exemption" shall mean permission approved by Douglas Shire Council in writing, and accepted by an applicant, that modifies or waives any water conservation measure under this policy.

"Exemption permit" shall mean a permit issued by Douglas Shire Council granting an exemption from water conservation measures to an approved exemption holder. An exemption permit must be displayed in a prominent position on the puthe exemption holder, an approved property address, an approval number, any conditions attached to the approval, and a commencement and expiry date, &/or a Level to which the approval is given.

"Fixed sprinkler" shall mean a sprinkler supplied by a fixed pipe or hose.

"Hand-held hose" shall mean a hose or pipe used to convey water, held in the physical possession of a person, or under the supervision of a person aged 16 years or over, controlling the efficient distribution of water.

"Microspray" shall mean a watering system that creates a fine jet or mist of water, and must incorporate a manual or automatic timer in operational condition.

"Non-active playing surface" shall mean that area of any sports ground that is not an active playing surface as defined.

"Paved area" shall mean footpath, driveway, hard standing area or similar having an impervious surface, such as concrete, asphalt, paving stones, tiles, etc.

"Portable wading pool" shall mean any demountable, temporary and transportable pool having a capacity less than, or equal to, 500 litres.

"Private pool and spa" shall mean any pool, spa or ornamental pond which is not a Douglas Shire Council owned public asset.

"Public pool" shall mean pools open to the public or individuals operated by Douglas Shire Council.

"Public spa" shall mean spas open to the public or individuals operated by Douglas Shire Council.

"Private garden" shall mean land, garden, lawn or grassed area used in relation to residential purposes, industrial, commercial or farming activities, hospitals and aged care facilities, schools, college, university and research facilities, cemeter adjacent to a private garden, excluding sports ground contained within such.

"Public parks and gardens" shall mean land, garden, lawn or grassed area controlled by Douglas Shire Council, or other statutory public authority, including a nature strip, road verge, median strip, roundabouts, botanic gardens, and footpatl

"Sports ground" shall mean land used for the purpose of any sport, game or other form of recreation.

"Sprinkler" shall mean a pipe or hose system and nozzle, soaker-hose or similar device used to distribute, sprinkle or spray water in any manner other than by a hand-held hose, excluding microspray and drip systems, misting systems used in or fogging systems use in commercial poultry industry.

"Level" shall mean the increment as set out in Schedule 1 of this policy designating particular water conservation criteria.

"Timer" shall mean any electronic or mechanical timing device that is used to regulate the time and duration of water flow to a sprinkler, microspray or drip watering system.

"Trigger nozzle or twist nozzle" shall mean a control nozzle intended to be used by persons that stop the flow of water by means of a lever or similar device that positively shuts off the supply of water when released.

"Water" shall mean potable water supplied from Douglas Shire Council's water supply system.

"Water supply system" shall mean Douglas Shire Council's infrastructure assets associated with the provision and distribuation of water to customers, consumers, users and transporters of water.

"Water toys/facilities" shall mean any entertainment toy, facility or structure, which is operated by, or uses, non-reticulating running water from a hose or pipe as part of its use.
