As applicant, you are encouraged to rigorously pursue opportunities for co-location with this particular service provider. It is undesirable to have two independent communication facilities located so close to each other.

Please note you are advised to explore the opportunity of co-location prior to committing further resources to the application in addressing the further information request items below.

- Undertake site survey locating the circumference and extent to canopy of each tree
 within the immediate vicinity of the proposed facility and details what vegetation is
 proposed to be removed or pruned to accommodate the facility. Please detail the
 location of the trees along the frontage of Old Port Road and the relationship with
 the proposed access.
- Provide a contour plan detailing existing and proposed ground levels. In addition provide a detailed drainage plan detailing the drainage of the site and the existing swale drain. The drainage plan is required to illustrate the works necessary to avoid ponding water.
- 4. Provide an accurately located photo-montage of the proposed telecommunications facility with views from both Old Port Road and Port Douglas Road.
- 5. 'Application of the Industry Code C564.2011 Precautionary Approach to Radio Communication Infrastructure Placement and Design' is referenced within your planning application. Sub-clauses 4.1.5 (d) and (f) explicitly refer to avoiding community sensitive locations and require that the outcomes of community consultation with affected parties be taken into consideration. The response at 4.1.5 (f) which states 'The outcomes of the consultation processes with identified affected parties will be taken into considered (sic) during the development application process' is an inadequate, and possibly premature statement. Please advise what consultation processes will be undertaken during the development application process and what outcomes from identified affected parties will be implemented as a consequence of this consultation.
