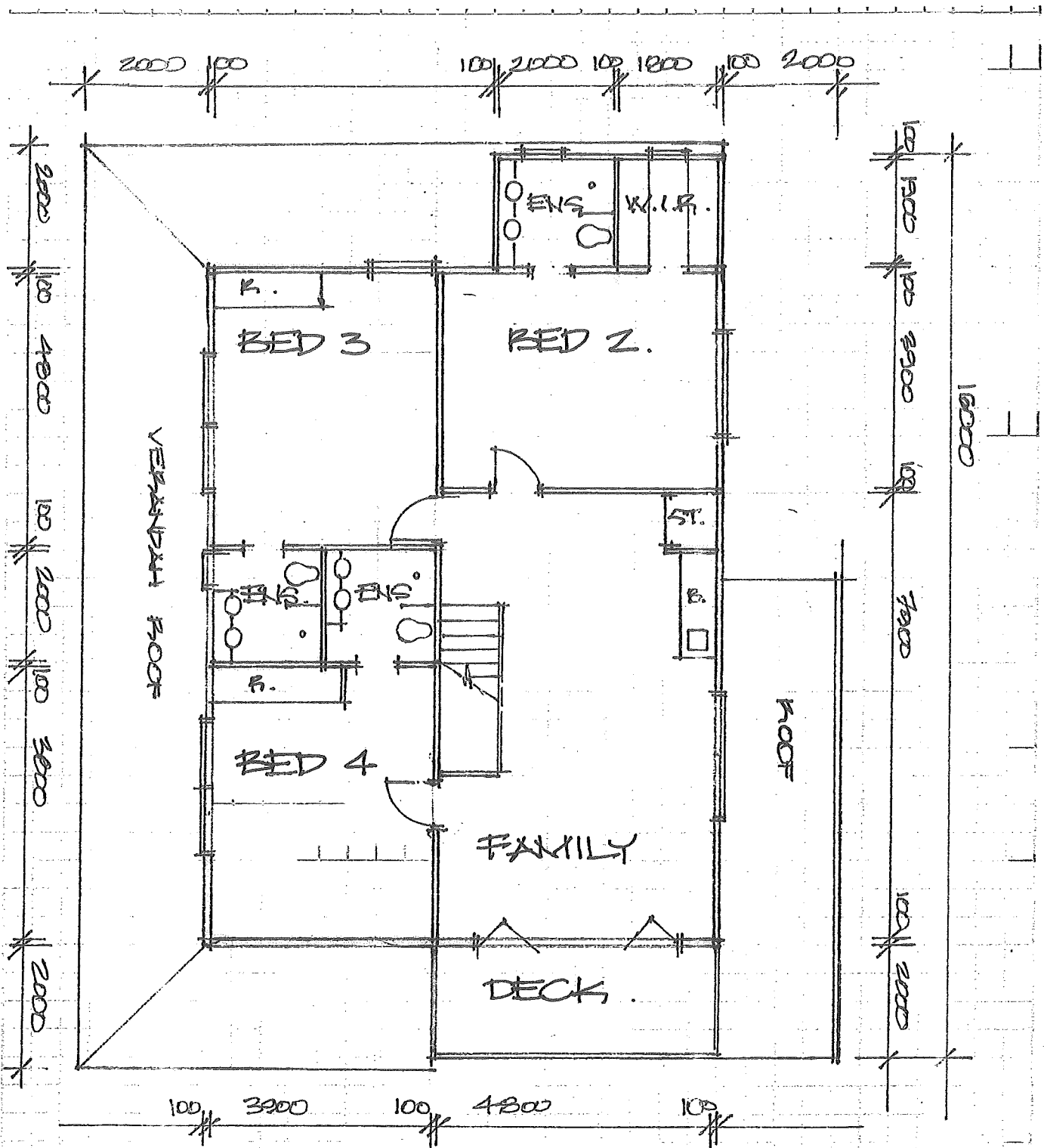

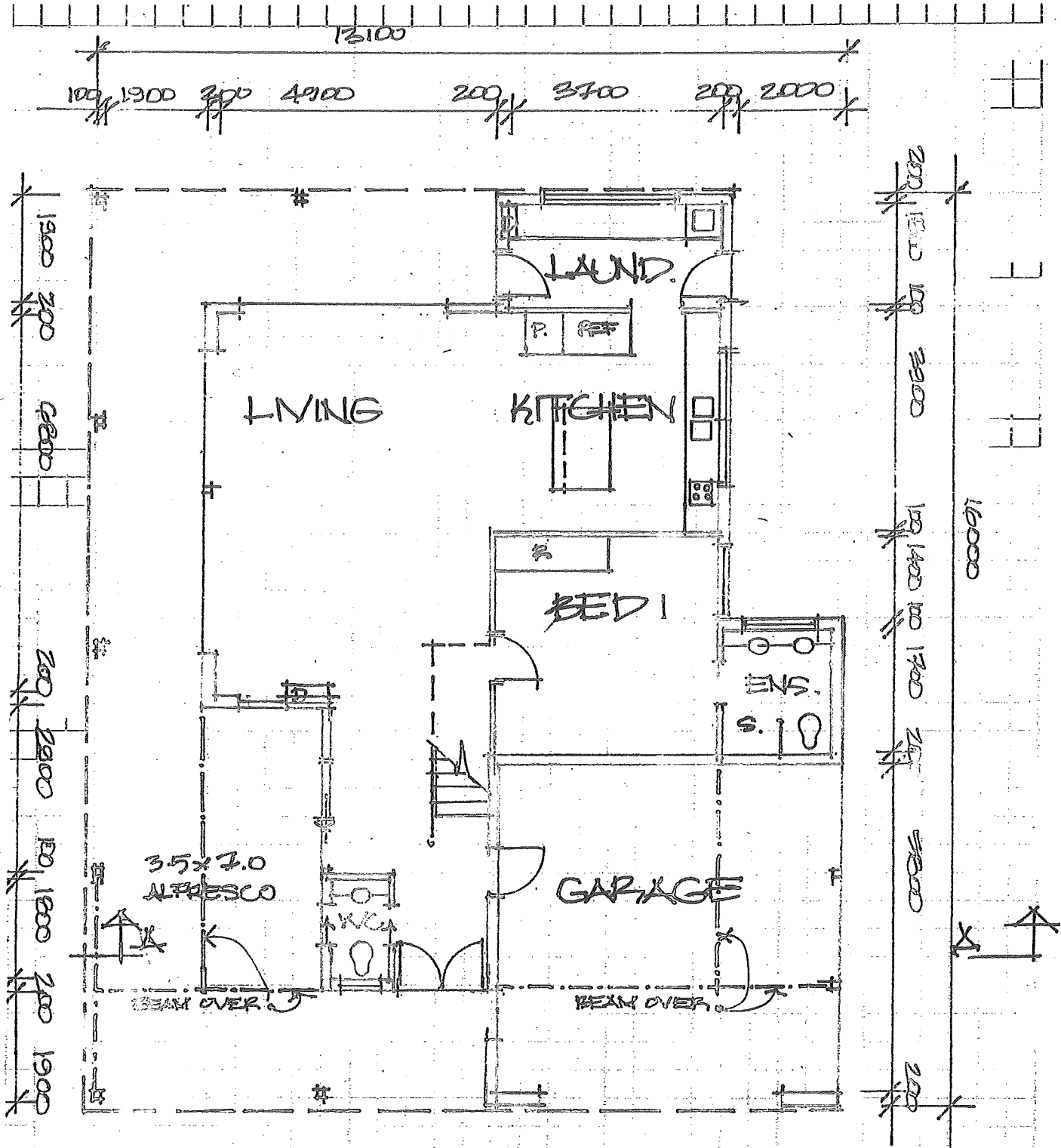


FIRST FLOOR PLAN 1:100

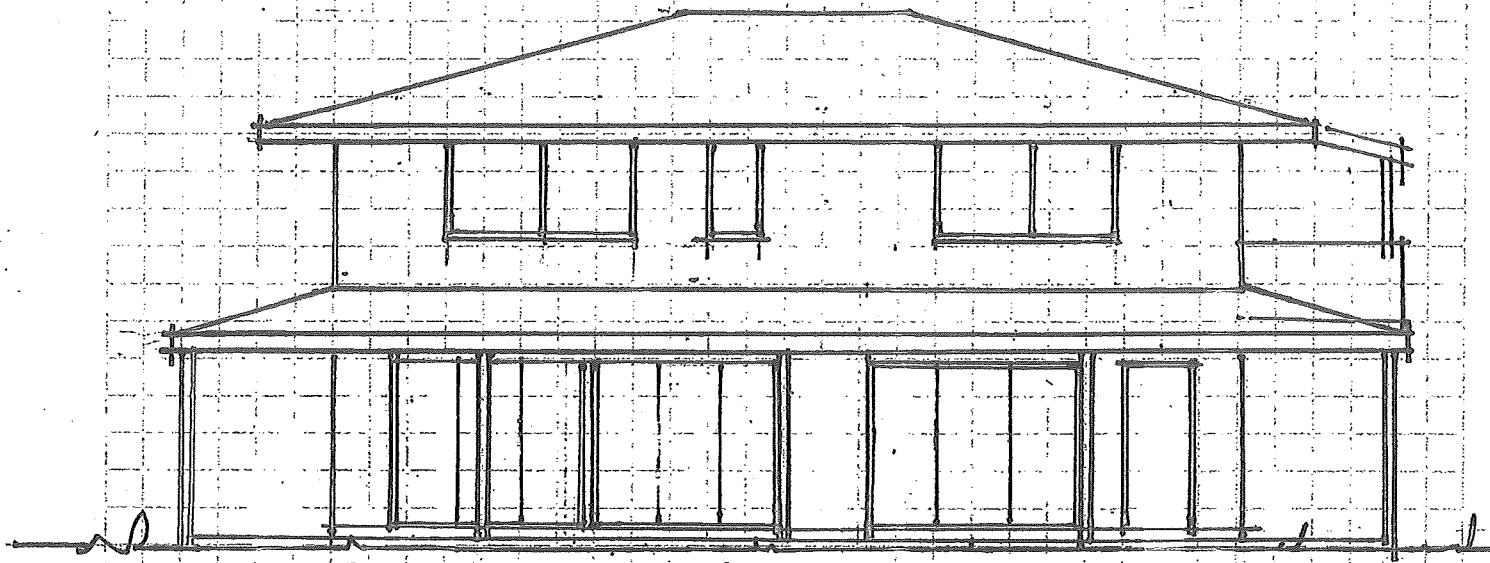


GROUND FLOOR PLAN 1:100

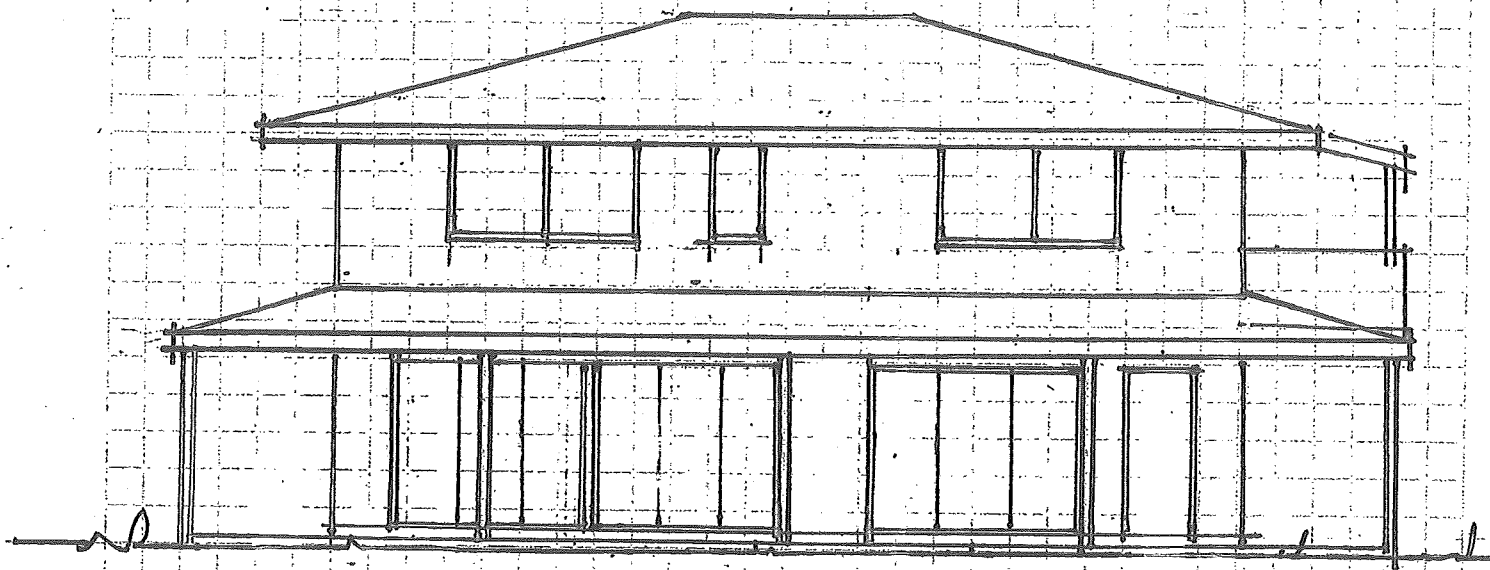


GROUND FLOOR PLAN 1:100
