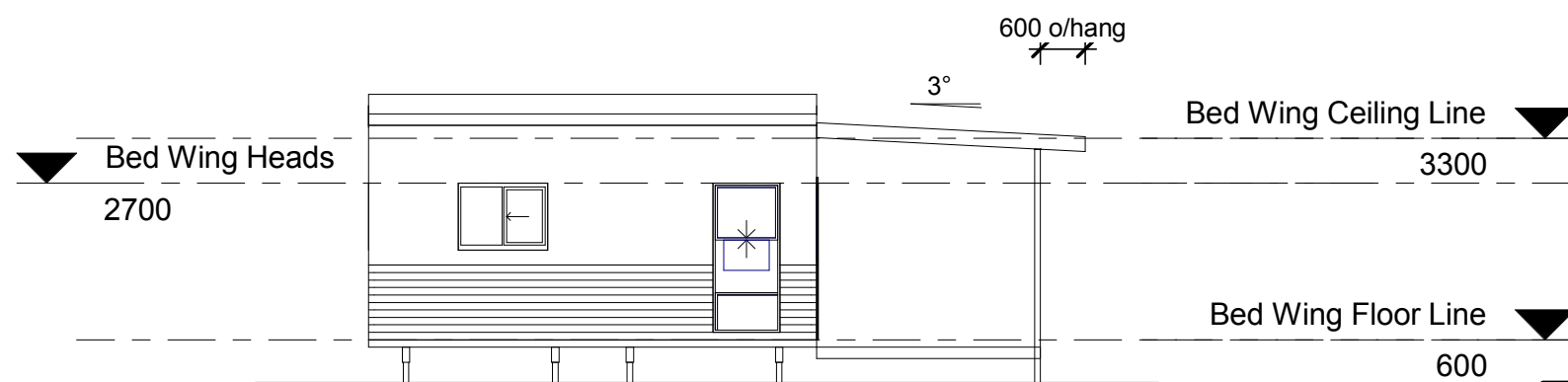
1 Bed Wing Floor Plan
