NOTICE REGARDING INTENDED START DATE OF PUBLIC NOTIFICATION –
PROPOSED DEVELOPMENT PERMIT FOR A COMBINED APPLICATION - MATERIAL
CHANGE OF USE, AND OPERATIONAL WORKS (IMPACT ASSESSMENT) AT LOT 7 CAPE

Pursuant to section 17.2 of the *Development Assessment Rules* ('the DA Rules'), we hereby provide notice to Douglas Shire Council of the intended start date of public notification for the above-referenced development application, being formally described as:

- Combined Application for a Development Permit for:
 - o Material Change of Use for:
 - Stage 1 Service station, Shop and Food and drink outlet;
 - Stage 2 Dwelling-house; and
 - Stage 3 Nature Based Tourism for forest stay comprising two accommodation units; and
 - o Operational Work for 2 x advertising devices to be erected at Stage 1

Public notification of the application is intended to occur as detailed in the below table:

17.1(b) giving notice to the adjoining owners of all lots adjoining the premises the subject of the application	To be posted on or before Friday 28 November 2025
17.1(c) publishing a public notice complying with the public notice requirements stated in the confirmation notice.	Notice to appear in the Cairns Post on Saturday 29 November 2025

The public notification period for the application is proposed to occur from **Monday 1 December - Friday 19th December 2025** (15 business days).
