

Re: Opposition to the Proposed Sand Quarry at Bonnie Doon Road

I am writing as a local resident and ratepayer to formally oppose the proposed sand quarry at Bonnie Doon Road. This proposal represents a significant zoning change from rural to industrial, a decision that warrants thorough public scrutiny, transparent consultation, and a comprehensive environmental impact assessment.

2. Health Risks:

Quarry dust contains fine particles that can lead to respiratory issues such as asthma, bronchitis, and silicosis. These risks extend to workers and nearby communities.

3. Impact on Property Values:

The presence of a sand quarry will undoubtedly reduce property values in Cooya Beach and surrounding areas, compounding the financial burden on local residents.

4. Quality of Life:

The prolonged industrial operation will fundamentally change the character of the region, degrading the peaceful, rural lifestyle that drew many residents here.

Lack of Consultation:

It is deeply concerning that the community has not been adequately consulted on this proposal. A zoning change of this scale demands meaningful engagement with residents and stakeholders, along with the completion of a robust environmental impact study to assess the long-term consequences.

I urge the Council to reconsider this proposal and prioritize the protection of our environment, community, and local economy. Allowing such an intrusive industrial activity to proceed without comprehensive study and public support sets a dangerous precedent for our region.
