We act on behalf of Mr Fred Langton, 'the Applicant' in respect of the above described Development Application.

With regard to the Panel's correspondence, dated 23 March 2010 and the outcomes determined at the site meeting held with the Panel on 30 April 2010, please find **attached** the plans prepared by Total Project Group which we believe reflect and address the outcomes determined at the site meeting.

The plans prepared by Total Project Group reflect the changes proposed to the unit development principally relating to the roof design as viewed from Murphy Street. The design changes are able to be undertaken without exceeding the 11 metre height limit and without needing significant changes to the overall building design.

A Comparative Elevation Plan has also been prepared which clearly shows how the existing land form on-site will result in a building form which is 2 metres lower than the unit development located to the right (as viewed from Murphy Street).

The design changes proposed in response to the concerns raised by the Panel provide for a form of building development which is subservient to the scale of building development located adjacent to it and provides for a building design which incorporates the vernacular architectural design features sought to be established within the Port Douglas locality. The proposed unit development, incorporating the design changes, is recommended for approval by the Panel.


