wildPLAN, act on behalf of *Jabalbina Yalanji Aboriginal Corporation RNTBC*, in providing formal notice, pursuant to Section 52 of the Planning Act 2016 (Qld), to withdraw development application *MCUI 2024_5698/1*.

From 52(1) of the Planning Act 2016:

"An applicant may change or withdraw a development application, before the application is decided, by a notice given to the assessment manager and, for a withdrawn application, any referral agency."

It is acknowledged that a notice to stop the decision-making period for 130 days was provided to Council on **16 April 2025**, with the stop-the-current-period action due to end on **24 October 2025**, and the decision-making period due to conclude on **3 November 2025**. Formal correspondence requesting to end the stop the current period action and resume the decision-making period was provided to Council **Thursday 25 September 2025**.

In accordance with section 52 of the Planning Act 2016, the Applicant formally requests withdrawal of the development application effective from the date of Council's receipt of this notice (**Friday 26 September 2025**).
